This is **Part 4** of the seven part series, a **Guide to Major Changes to Canada's Temporary Foreign Worker Program**.

Last week I covered the transition plan including the details of the application form, what each plan must include and exemptions. Visit <u>Part 3 - Employers Must Now</u> <u>Report On Rejected Canadian and Permanent Resident Applicants</u> if you missed it. This week I'll cover another major change in the LMIA process where employers will now have to provide information on the number of Canadians/permanent residents who responded to the job postings.

This Week: Faster Processing for the Highest Demand, Highest Paid and Shortest Duration Occupations

For certain occupations, LMIAs will be processed much faster than the old LMOs. The highest demand, highest paid and shortest duration occupations will be processed in 10 days.

The 10 day service standard for the highest-demand occupations will initially be limited to the following list of skilled trades where the wage paid is at or above the provincial or territorial median wage.

Skilled Trades and Higher-Wage

The position is for a skilled trade on this list of eligible occupations and has a



The highest-paid occupations will require that a TFW be paid at or above the top 10% of wages earned by Canadians in a given province or territory where the job is located according to the chart below. Employers should note that the wage cut-off for this category is determined by province-wide statistics. If the prevailing wage for a specific highly skilled occupation is below the top 10% of wages earned in a province, an LMIA can still be requested but the 10 day service standard may not apply.

Top 10% Wage Earners

The prevailing wage for the position is at or above the top 10% of wages earned by Canadians or permanent residents in the province/territory, where the job is located.

The shortest-duration occupations will only be available for individuals employed in Canada for 120 calendar days or less in any occupation where the wage offered is at or above the provincial or territorial median wage.
