The Court has instructed me to inform you that oral argument on your petition for appeal has been scheduled before a panel of Justices at 9:00 a.m. on Thursday, July 7, 2011 for 10 minutes in the Prince William County Circuit Court which is located in the Prince William County Judicial Center, 9311 Lee Avenue, Manassas, Virginia. Because panels frequently run ahead of schedule, the Court requires counsel to arrive 1 hour prior to the specified time, except in cases set for 9:00 a.m., in which case counsel should arrive at 8:30 a.m. Failure to answer when your case is called may be deemed a waiver of your right to present oral argument.

Upon entry into the Prince William County Judicial Center main entrance, and after passing through the security screening station, please take the elevator on the right to the third floor. You will then check in with a Supreme Court Staff Attorney or Law Clerk, who will be stationed outside Circuit Courtroom #4, where your argument will be heard. You should remain in that courtroom until your case is called. Directions and parking information for the Prince William Circuit Court are included on the attached page.

Please note that cameras, cellular telephones, pagers, tape recorders, computers, or other electronic devices are not permitted in the courtroom when the Court is in session or holding writ panels. Security will not allow persons to enter the courtroom with these devices.

Location of the Hearings

The Supreme Court of Virginia will hear oral arguments in Circuit Courtroom # 4. You must pass through security at the Judicial Center entrances. Take the elevator near the main entrance on the right to the 3rd floor. When you exit the elevator proceed to your left. Courtroom # 4 will be approximately halfway down the hallway to your left. Cell phones, laptops and electronic devices of any kind are not allowed in the Courthouse when the Supreme Court is in session. You will be asked to return them to your vehicle.

Directions:

Via I-95 from the South: - Take Dumfries Exit # 152B onto Dumfries Road/Route 234 North towards Manassas. Continue on Dumfries Road/Route 234 North for 14.6 miles, past the intersection with Prince William Parkway/Brentsville Road. Turn right at the stoplight onto Dumfries Road Business Route 234. Continue on Dumfries Road Business Route 234 for 2.6 miles through the railroad underpass and two traffic lights. Turn left on Lee Avenue and proceed to the Courthouse at the end of the street.

Via I-95 from the North: - Take the Prince William Parkway Exit # 158B and continue along Prince William Parkway into Manassas. Pass the intersection of the Parkway with Liberia Avenue. Continue straight to the Richmond Avenue/Dumfries Road/Grant Avenue intersection. Turn right on Grant Avenue/Route 234 North. Pass through the railroad underpass and two traffic lights. Turn left on Lee Avenue and proceed to the Courthouse.

Via I-66 from the West: - Take Manassas Exit # 47 and continue on Sudley Road/Route 234 South for 4.5 miles to Lee Avenue. Turn right on Lee Avenue and proceed to the Courthouse.

Via I-66 from the East and Via Route 28 from the North: - Take the Dulles-Centreville Exit # 53 and continue along Route 28 South for eight miles to Grant Avenue/Route 234. Turn right on Grant Avenue. Take the first left on Lee Avenue and proceed to the Judicial Center at the end of the street.

Via Route 28 from the South: - Proceed into the City of Manassas on Route 28 North. After Center Street becomes one way, continue two blocks to the intersection with Grant Avenue/Route 234. Take a left on Grant Avenue and go two blocks to the intersection with Lee Avenue. Take a left on Lee Avenue and proceed to the Courthouse.

Via Route 234 By-Pass: - Take the 234 By-Pass to 28 North. Follow 28 North into the City of Manassas. After Center Street becomes one way, continue two blocks to the intersection with Grant Avenue/Route 234. Take a left on Grant Avenue and go two blocks to the intersection with Lee Avenue. Take a left on Lee Avenue and proceed to the Judicial Center at the end of the street.

Parking - There are several Public Parking Lots near the Judicial Center along Peabody Street and Mosby Street. From Lee Avenue approaching the courthouse, turn right onto Peabody Street for Public Parking lots to the right and left. Additional parking is available in a lot on Mosby Street – drive one block on Peabody, turn left onto Mosby Street and the lot is on your right.
