Mr. Bouchard suggested that Supervisor Kaiser speak to Mr. Aaronson to have a voice be on the Review Board.

Highway Report – Superintendent Morrell reported that we should be getting the new truck soon. There has been very little plowing this winter so far.

Councilman Collinsworth stated that that Mr. Morrell is doing a good job.

Mr. Morrell has received a Shared Service Agreement for emergency Assistance. It will be Resolution #09-16 if approved.

I am submitting my resignation and asking the Town of Romulus to appoint a new Attorney, Patrick J. Morrell, Esq., Seneca Falls, NY."

"Supervisor Kaiser Said, "on behalf of The Town of Romulus, I would like to thank you for your years of service and will regretfully accept the discontinuation of your contract."

With that I would like to propose the services of Pat Morrell, who is with us tonight, to continue on to work as our town attorney. I would like to put a resolution on the table tonight to appoint him under contract on the same terms that we had for Mr. Getman.

William Karlsen asked to speak. "I mentioned this back in November, 2015, but with elections and budgets and all that, I would like to readdress this issue. Last October Finger Lakes Times, in transfers, had a tax parcel, owned by Michelle Sanders and sold to the Finger Lakes Land Trust."

The assessment on that property contingent to Blue Heron Point, Rte 89, is \$630,000.00. It was bought by the Finger Lakes Land Trust and removed from the tax rolls. When these properties get bought up by these entities as a land trust, is there any requirement procedurally that the town tax jurisdiction need to be notified. Attorney Morrell will look into it.

There are 2000 acres on the Depot that Mr. Hayssen from the Town of Varick wants for the white deer only. No one can buy that land.
