Global Situation Update: May 20, 2021

WHAT WE'RE WATCHING

Today, the EU Parliament is expected to vote on a motion to formally freeze the EU's Comprehensive Agreement on Investment (CAI) with China over sanctions imposed by Beijing on several European lawmakers earlier this year.

The draft motion also reportedly calls for increased EU cooperation with the US on China policy, as well as attention paid to Taiwan. If passed, the motion will mark a further blow to EU-China relations and undermine the chances of the investment deal, seven years in the making, ever being ratified.








Global

Confirmed coronavirus infections topped 164.8 million with more than 3.4 million deaths.

Globally, in the past week, the number of new cases and deaths continued to decrease, although overall counts for both remained high with just over 4.8 million new cases and nearly 86,000 new deaths reported in the past week.

COVID-19 Vaccine

Dr. Fauci said Wednesday that children in the US will likely be able to receive COVID-19 vaccines by the end of the year or beginning of 2022.

- A letter published in the British Medical Journal on Wednesday urged G7 countries to pay for twothirds of the costs required to vaccinate the global population.
- UK Prime Minister Johnson said there is "increasing confidence" that vaccines are effective against all variants of COVID-19.
- The US FDA has eased the cold storage rules for the Pfizer-BioNTech coronavirus vaccine so that the doses can be kept longer at normal refrigerator temperatures.
- Emergent BioSolutions said it has made enough ingredient for more than 100 million Johnson & Johnson shots.



Markets & Business

German lender Deutsche Bank announced it will invest more than 200 billion euros (\$244 billion) into sustainable financing and investments by 2023, two years earlier than initially planned.

- Cryptocurrencies saw a turbulent trading day Wednesday following signals of a Chinese crackdown digital currency; Bitcoin fell as much as 30 percent before regaining some losses.
- Lowe's booked a 26 percent year-on-year rise in fiscal Q1 sales in another sign of the continuing DIY boom.
- Target and TJ Maxx recorded surges in fiscal Q1 sales as reopening and stimulus money fueled consumer spending.
- **Kroger** became the latest US retailers to require customers and employees to wear a mask if they are fully vaccinated.

- **Microsoft** announced that it will officially retire Internet Explorer in June 2022.
- Royal Dutch Shell has agreed to sell its stake in a offshore gas field in the Philippines for \$460 million as part of its strategy to narrow its oil and gas operations.
- A number of European companies, including Carrefour and LVMH, have turned to share buybacks as they regain cash flow from economic recovery.



Africa

• **Zambia's** main opposition candidate, Hakainde Hichilemare, was officially cleared to run for president.

• The UNHCR called on **Tanzania** to stop deporting asylum seekers fleeing violence in **Mozambique**.

- Malawi destroyed 20,000 doses of AstraZeneca vaccine that expired 18 days after arrival, despite assurances from the AU and WHO that the doses were safe until mid-July.
- Kenya set to appoint its first female chief justice.
- Spain's high court has served Western Sahara independence leader Brahim Ghali with a June 1 summons for a preliminary hearing in a war crimes case against him.







Asia

China released the first photos taken by its Zhu Rong Mars rover.

Doctors in Nepal worry that the country's outbreak is on an even worse trajectory than India's.

 Officials in Malaysia are debating a full national lockdown as daily COVID-19 cases hit a record high of 6,075.

Taiwan raised its alert level for the whole country after recording another
 267 local infections. Taiwan will further curb water use in chip-making hubs as the country's drought persists.

Thailand is aiming to vaccinate up to 70 percent of its population by September.

A comment from Delhi's chief minister that a "new form of corona found in Singapore" is driving
 India's current wave of cases has prompted criticism from other Indian politicians and caused tensions with
 Singapore. India's top refiner cut crude processing by 10 percent.







Europe

 The European Central Bank warned that rising debt levels could trigger financial instability in the wake of the pandemic.

• Scottish first minister Nicola Sturgeon put former Westminster heavyweight Angus Robertson in charge of the push for a second independence referendum as part of a major cabinet reshuffle.

- Online files show that medical and personal information about Irish
 patients that was stolen last week is now being shared online; Ireland's Health Service Executive (HSE) is trying to determine how much
 patient data was compromised. London's Metropolitan Police have tripled amounts of cash seized within a year during the pandemic due
 to disruptions to money laundering operations.
- Armin Laschet gave his first big speech on foreign and defense policy since being elected as the center-right coalition's candidate for **German** chancellor in September elections; he called for the creation of a national security council and more "proactive" foreign policy.
- The number of new coronavirus cases in **Europe** dropped by 60 percent over the past month per the WHO, as vaccinations and other public health measures helped temper a winter surge. However, "pockets of increasing transmission" could lead to "dangerous resurgences" of the virus, particularly as new variants spread. The **EU** provisionally agreed to open to fully vaccinated travelers and ease rules that ban non-essential travel from countries with high levels of COVID-19. The **UK** health secretary said that increased vaccinations and surge testing will be offered to residents at potential COVID-19 hotspots in an effort to contain the Indian B.1.617.2 strain.

Middle East


Saudi Arabia's foreign minister personally addressed Iran-Saudi
meetings for the first time after the Kingdom confirmed the meetings
last week, saying the "exploratory talks" are at an early stage, but "hopeful."

• **Lebanese** Foreign Minister Wehbe submitted his resignation after comments implying that **Gulf states** fueled the rise of ISIL.

 Kurdish authorities in Iraq canceled a planned price hike on fuel after protests left two dead.

• **Tunisian** finance minister Kooli said the country has no intention of rescheduling its foreign debt, despite a dire domestic situation.

• US President Biden called more strongly for de-escalation in a phone call with Israeli Prime Minister Netanyahu. The US signaled that it would veto a French UN Security Council resolution calling for a ceasefire. Israel fired artillery into southern Lebanon following rocket attacks into Israeli territory. Facebook established a 24-7 special content moderation center to respond to content related to the conflict. Renewed pro-Palestinian protests broke out in Tunisia and Kuwait; Kuwaiti protesters burned an Israeli flag and denounced Arab-Israeli normalization. Norway's sovereign wealth fund has excluded two Israeli companies for constructing and letting out buildings in Israel's settlements in the occupied West Bank.



Americas

• Farmers in **Argentina** will today begin a nine-day strike to protest a month-long suspension of beef exports aimed at reining in inflation.

Colombian anti-government protests entered their fourth week.

Brazil's federal police carried out searches Wednesday to probe whether
 Environment Minister Ricardo Salles and other key ministry officials facilitated
 illegal timber exports to the US and Europe.

 Canadian home prices rose sharply from March to April, continuing a recovery trend. In an effort to deter Canadians from crossing into the US to be vaccinated, the Canadian government announced these travelers would not be exempted from mandatory quarantine upon their return. The US border agency said it would deny entry to any Canadians attempting to drive into America with the sole purpose of getting a coronavirus vaccination.







Americas: US

- Across the nation, 159.2 million people have received at least one dose of vaccine, or 47.9 percent to the total population. Maine became the first US state to fully vaccinate 50 percent of residents. The US surpassed 33 million total COVID-19 infections.
- Senate Minority Leader McConnell (R-KY) publicly announced his opposition to a commission to investigate the January 6 Capitol riot.
- Minutes the Fed Open Market Committee's late April meeting show that some Federal Reserve officials
 argued that the central bank should move towards tapering monetary support for the economy if
 recovery continues to accelerate. A study from the New York Federal Reserve found that the end of US
 mortgage forbearance is unlikely to prompt as many delinquencies as the financial crisis.
- The Biden Administration is waiving Trump-era sanctions on the company in charge of the Nord Stream 2
 gas pipeline, a move welcomed by Germany but criticized by politicians worried about Russia gaining
 leverage over the EU.

After eleven days of continuous fighting between Israel and Hamas, international pressure is mounting on the two sides to end violence and seek a ceasefire.

After providing Israel with the "diplomatic space" and time to hit Hamas hard, President Biden conveyed to Israeli Prime Minister Netanyahu on May 19 his expectation for a "significant de-escalation today on the path to a ceasefire." Netanyahu thanked Biden for his steadfast support, but noted Israel will continue with its operation until it achieves its goals. Egypt, Jordan and Qatar have been conveying stern messages to Hamas to de-escalate as well, but for the time being Hamas is determined to continue with its strategy, hoping to strike "qualitative" Israeli targets, before agreeing to a ceasefire. With each side looking to end the fighting with a "victory photo," the world's growing impatience will be critical in paving the way to a ceasefire, possibly before the end of this week.

Hamas' actions took most global and regional actors by surprise. Hamas took advantage of rising tensions between Israelis and Palestinians in East Jerusalem during Ramadan over the sensitive issues of access to the Haram al-Sharif and pending evictions of several Palestinian families from their homes in an East Jerusalem neighborhood. The latter is a long-running point of contention; Israeli settlers are seeking to populate this neighborhood as part of a larger agenda of consolidating Israeli control overall all of Jerusalem and preclude the option for a Palestinian capital in East Jerusalem by imposing facts on the ground, difficult to reverse in negotiations.

Hamas, through its rocket launches into Israel beginning on May 10, has managed to politicize and militarize the divisions over Jerusalem in an unprecedented way, furthering its reach beyond the occupied territories into inner Israel. Many Palestinian Arab citizens of the Jewish state felt motivated to protest Israel's handling of the events in Jerusalem and clash with Israeli police and Jewish citizens. More than seventy years of a relatively peaceful coexistence in mixed Arab-Jewish cities like Haifa, Lod and Ramle soon began to unravel, as widespread violence between Arabs and Jews erupted in full force, with Israeli authorities unable to take control of the situation.





On May 18, a general strike by Israel's Palestinian Arab citizens was held. While some of the tensions have subsided, it is estimated that it may take years to return to something like the status quo ante.

Impact on Israeli Politics

On the eve of the conflict between Israel and Hamas, all indications were that Member of the Knesset (MK) Yair Lapid, Leader of the centrist Yesh Atid Party and MK Naftali Bennett, Leader of the rightwing Yamina Party would reach an agreement to establish a national unity government, leaning on a very narrow majority in the Israeli Knesset, which will not include Netanyahu and the Likud Party. Lapid and Bennett were reportedly in an advanced stage of discussions on a power-sharing mechanism, policy guidelines and the division of cabinet portfolios in their new government. The end of Netanyahu's rule after 15 years in office was all but certain. At the center of the power-sharing arrangement was an agreement that there will be a rotation of the prime minister position between Bennett and Lapid, with Bennett taking the role first for two years and Lapid serving as Alternate Prime Minister and Foreign Minister for the first two years. The new coalition (aka the "Change Bloc")

was to include seven parties across the entire political spectrum and also rely on the tacit support of the Islamist Arab Ra'am Party, led by MK Mansour Abbas.

Then came the events in East Jerusalem and the Hamas offensive. As rockets were falling throughout the south of Israel and the Tel Aviv area, and as tensions between Palestinian Arabs and Jews inside Israel spiraled out of control, pressure on Bennett was building up from within his own party, as well as from other right wing constituencies, not to side with Lapid and not to opt for a government leaning on several left wing parties, and relying on the Ra'am Party. Three days into the fighting, Bennett made clear he was abandoning the idea of a coalition and government of the Change Bloc and is resuming negotiations with Likud and Netanyahu to explore if there is an option for a right wing government and coalition. Bennett explained that at a time of a national crisis, security issues are top priority, and the domestic-civilian issues are only secondary.

Lapid's mandate from President Rivlin expires on June 2. Lapid expressed regret at Bennett's decision but vowed to continue with



efforts to establish a government. However, Lapid's chances of succeeding without Bennett are extremely low. If he fails, the president will transfer the issue to the Knesset. Members of Knesset will have 21 days to try and agree on a candidate for Prime Minister.

Before May 10, Netanyahu's supporters and allies began talking about the "day after Bibi," yet as events unfold, he may remain in his position until the next elections and have another shot at winning. Many of Netanyahu's opponents and critics have accused the Prime Minister of stirring tensions in Jerusalem intentionally, hoping it will bring Bennett and Yamina back into the right wing camp. Others have argued that Netanyahu is not ending the war against Hamas in order to "buy time" and let Lapid's mandate run out. Whether it is true or not, Netanyahu's dream scenario is becoming a reality.

Intra-Palestinian Dynamics

Hamas in its actions has upstaged the Palestinian Authority (PA), its leader President Abbas and its nemesis, the Fatah movement. In the aftermath of Abbas' decision to indefinitely postpone the elections to the Palestinian Legislative Council (set for the end of

May), Hamas did not hide its anger and vowed not to sit idly by. Nevertheless, Hamas' decision to begin its rocket attacks against Israel was not planned as a response to the election postponement, but rather Hamas seized on an opportunity created by the events in East Jerusalem, to portray itself as the coming to the defense of the al-Agsa Mosque and Jerusalem and at the same time strengthen its image and score points in Palestinian public opinion. Abbas' weakness was once again exposed and once the Israel-Hamas fighting ends, he will face an emboldened Hamas that can destabilize the West Bank if it decides to do so. Israeli-PA security cooperation continued almost interrupted during this round of fighting, as the PA security forces have effectively maintained order in the West Bank. There were sporadic protests and several attacks against Israeli soldiers and civilians, but the Israeli authorities are bracing for a possible escalation in violent activities in the West Bank when the fighting in Gaza dies down.

Conclusion

The current round of fighting between Israel and Hamas is impacting great power competition, straining US-Israel relations and is putting



recent Arab-Israeli normalization agreements to the test. Domestically, it has the potential of leading to a tectonic shift in the Palestinian politics with Hamas in a position to gain the upper hand, and in Israel it may provide Netanyahu the opportunity to stay in power longer. Some analysts have pointed out that Netanyahu and Hamas leaders have a common interest, each profiting politically from a confrontation. This argument however is counterintuitive to Israel's interest in long term security and stability in the West Bank. Strengthening the PA at such a delicate time makes great sense and it is a goal the Biden Administration is pushing for. The unanswered question is whether Israeli policy will be driven by Netanyahu the statesman or Netanyahu the politician. Only time will tell.






Coronavirus Condition Updates


As of 2100 hours US EDT on May 19, 2021






