WHY ADVANCE DIRECTIVES/ LIVING W

Modern advances in science and medicine h prolongation of the lives of many seriously ill individuals realistic prospects for improvement or cure. For some indextended life is experienced as meaningful and of benecontinuation of life may seem to provide nothing medica serving only to extend suffering and draw out the dying p the inherent dignity and value of human life and within the fundamental right of individuals to make the necessary hea life-prolonging medical, surgical, or procedure means provide States acknowledge the right of competent adults

care decisions through the execution of advance directive durable powers of attorney, and to have their wishes resp limitations.

PURPOSE OF LIVING WILLS

In order to assure respect for patients' previously e capacity to participate actively in decision making has k facilitate and encourage a sound decision making process care representatives, families, physicians, and other heal active participants; to properly consider patients' inter determination and well-being; and to provide necessary ar concerning the termination of life-sustaining treatment for the law and policy of this State and the Legislatures h Advance Directives for Health Care Acts.

REQUIREMENTS OF STATUTE

The advance directive for health care (Living Will) r in accordance with the requirements of the state law. It mu front of an attorney at law, other person authorized to a presence of two subscribing adult witnesses. If the two they both must attest that the declarant is of sound m influence. A designated health care representative shall nc execution of the advance directive. Since this is a leg executed properly to be valid under the statute.

HEALTH CARE REPRESENTATIVE

The declarant must designate one or more representatives. "Health care representative" means the junder the Living Will for the purpose of making health care d
