# Global

Overnight, confirmed coronavirus cases rose to 70,809,766 in 217 countries and territories, with 1,590,499 deaths.

- The World Food Programme estimates that 270 million people are facing **starvation**.
- The World Bank estimates it will take two or three years for **global output** to return to pre-pandemic levels after the coronavirus is controlled.
- UN Secretary General Guterres denounced "vaccine nationalism," emphasizing the need for equity in access between wealthy and poor nations.
- Two studies in the medical journal JAMA found no increase in **stillbirths or preterm births** related to the pandemic.

- In the US, Moderna began a mid-to-late-stage clinical trial testing its COVID-19 vaccine candidate in adolescents aged 12 to 18 and aims for data ahead of the 2021 school year.
- Sanofi and GlaxoSmithKline said **clinical trials** of their COVID-19 vaccine showed an insufficient immune response in older people, delaying its launch to late next year.
- AstraZeneca will start clinical trials to test a combination of its experimental COVID-19 vaccine with Russia's Sputnik V shot aimed at boosting the efficacy of the British drugmaker's vaccine.

# **COVID-19 Vaccine**

Google will launch a knowledge panel feature in UK searches for vaccine-related information in order to connect people to health authorities and prevent the spread of misinformation.

- **Saudi Arabia** became the fourth nation to approve the Pfizer vaccine for emergency use.
- A panel of outside advisers to the US FDA voted overwhelmingly to endorse emergency use of Pfizer's coronavirus vaccine, paving the way for the agency to authorize the vaccine for a nation. Walmart announced that it was preparing over 5,000 US stores to receive vaccine doses and serve as distribution centers.
- Bahrain will provide vaccines to its citizens free of charge.
- Peru, Uruguay, Paraguay, Honduras and other Latin American countries are expressing interest in buying China's Sinovac Biotech vaccine CoronaVac.

- **Brazil's** health minister said the country plans to vaccinate its entire population in 2021.
- Japan plans to buy 10,500 deep freezers to store vaccines.
- Australia cancelled the production of a COVID-19 vaccine developed by the University of Queensland after trials showed it could interfere with HIV diagnosis.
- The Asian Development Bank has launched a \$9bn vaccine initiative to provide "rapid and equitable support" to developing countries in the region seeking to roll out mass Covid-19 inoculations.
- **Turkey** plans to roll out a China-made Sinovac vaccine in "only a matter of days."

### Markets

#### Eurozone bond yields rallied on Thursday after the ECB announced their bondbuying program extension.

- European shares slipped on Friday on worries over the economic impact of a resurgent COVID-19 pandemic, the fate of a Brexit trade deal and the stalled U.S. stimulus measures.
- Asian markets were mixed on Friday.
- **US stocks** slipped Thursday on a jump in weekly jobless claims.
- **Oil** jumped above \$50 per barrel for the first time since March.

- The UK's banking regulator will allow UK banks to restart **dividends**.
- The price on the EU Emissions Trading System (ETS) rose to a record high of €30.88 a ton, a development hailed as a landmark moment for the EU's efforts to curb emissions.



### **Business**

# A coalition of 30 CEOs, including those of Nike and Merck, are backing startup OneTen, which will focus on training Black candidates for corporate roles.


- **Lululemon** reported a 22 percent rise in Q3 revenues compared to last year as demand for home loungewear remained high.
- **Uber's** chief executive asked New York to give Uber drivers priority access to vaccines.
- Global **cinema** revenues are on course to drop by almost \$32 billion, or three quarters, this year.
- In a sign of growing acceptance for bitcoin, Massachusetts Mutual Life Insurance bought \$100 million of the digital currency for its investment account.
- A new US clean energy trade group, the American Clean Energy Power Association, tapped former Obama official Heather Zichal as CEO.

- **Costco's** quarterly revenue beat analyst expectations on continued strong grocery demand.
- Lockheed Martin Corp, the maker of the F-35 stealth jet, will join a project led by Mitsubishi Heavy Industries to build a new fighter plane that Japan's air force is expected to field by the mid-2030s.
- Hyundai Motor Group units and its chairman have agreed to buy an 80 percent stake in robot maker Boston Dynamics from SoftBank Group Corp.
- Swiss insurer Zurich is to expand in the US with the \$3.9 billion acquisition of MetLife's property and casualty insurance business.

### **Africa**

- South Africa's president blamed the country's second wave on "large parties with young people."
- Zambia began negotiations with the IMF for monetary support; last month, the country became the first to default amid the pandemic.
- Uganda revoked the media accreditations of all foreign journalists a month before ٠ the upcoming presidential election.
- **Cameroonian** forces ended the blockade on opposition leader Maurice Kamto's home; Kamto had been under house arrest since September, when he called for protests against the outcome of regional elections.
- Ghana's main opposition party announced that it would contest the results of the ٠ recent presidential election, which saw the incumbent narrowly win reelection.
- Two US Senators have called for possible sanctions against **Ethiopian** officials ٠ responsible for human rights abuses.





### Asia

- Singaporean officials reported that a man whose positive test forced a "cruise to nowhere" to return to port and thousands of passengers to quarantine was given a false positive.
- Japan reported a record 2,820 daily cases, further raising concern about strain on the country's medical system; some hospitals have begun limiting intake of non-coronavirus patients.
- New reports say that an annual closed-door China-EU trade forum was quietly canceled due to China's demands to ban participants critical of Beijing. Hong Kong democracy activist and media tycoon Jimmy Lai has been charged under the city's national security law on suspicion of colluding with foreign forces. China called US claims about risks to national security completely false, following a US decision to halt China Telecom US operations. China's security services have detained an employee at Bloomberg News' Beijing bureau on suspicion of endangering national security.

# Europe

- Both the **UK** and the **EU** warned that Britain is now more likely to leave the EU on December 31 without a Brexit trade deal than with an agreement.
- EU leaders agreed to prepare limited sanctions on **Turkish** individuals over an energy exploration dispute with **Greece and Cyprus**, postponing any harsher steps until March as countries sparred over how to handle Ankara.
- The EU settled the dispute over its €1.8trn budget as Hungary and
  Poland dropped objections about rule of law provisions in the fund. The deal reached by EU leaders in the early hours of Friday to cut net emissions at least 55 percent by 2030 is a step for the bloc towards having zero net emissions in 2050. The ECB launched a fresh round of stimulus measures, pledging to buy another € 500bn worth of bonds.
- UK Health Secretary Hancock announced secondary school children in the worst affected parts on London will be offered mass testing. London's coronavirus case rate jumped to the highest in England in the week ending on December 6. British travelers will be subject to EU travel restrictions, which bar nonessential visitors, from January 1. France delayed much of the planned easing of lockdown measures on December 15 and will institute a strict curfew to prevent another wave of COVID-19 cases. Large burial pits of mink in Denmark, culled in the wake of fears of coronavirus infection and mutation in the animals, have likely contaminated the groundwater. A Latvian hospital installed a vending machine for self-administered coronavirus tests. ICUs in Stockholm, Sweden surpassed 99 percent capacity. New figures show that Spain reported over 45,000 likely coronavirus deaths between March and May. Belgium surpassed 600,000 infections.

### Middle East

- President Trump announced that Israel and Morocco have agreed to normalize relations, and that the US will now recognize Moroccan sovereignty over the disputed Western Sahara.
- A Lebanese judge announced charges against several ministers and caretaker Prime Minister Hassan Diab for negligence in the Beirut port explosion. The UN-backed Lebanon Tribunal sentenced in absentia a Hezbollah member convicted of conspiring to kill former Lebanese prime minister Rafik al-Hariri in a 2005 bombing to five terms of life imprisonment.
- The US designated Yemeni Houthi officials as terrorists. The Saudiled coalition in Yemen announced that the internationally-recognized government and the southern separatists had begun implementing the Riyadh Pact to form a power-sharing government.





### Americas

- Argentine lawmakers debated a controversial bill Thursday that would legalize most abortions; both supporters and opponents of the bill staged protests.
- Election officials say that political allies of President Maduro won 91 percent of congressional seats in **Venezuela's** recent opposition-boycotted election.
- **Mexico's** Senate approved a proposal from President Lopez Obrador to restrict US agents operating in Mexico. Members of the Mexican retailer's association ANTAD said same-store sales rose 2.6 percent in November y/y.
- After weeks of devastation from hurricanes, a group of hundreds of Hondurans are gathering to walk together in a caravan heading for the US.
- Ecuador surpassed 200,000 confirmed virus cases.



# **Americas: US**

- New **US jobless claims** surged to 853,000 last week.
- Hospitalizations continue at all-time highs. Seven states registered more than 10,000 daily new cases yesterday, with California again posting more than 30,000, and eight states registered more than 100 deaths, another record. CDC Director Redfield said that US daily death tolls will exceed 9/11 tolls for the next two or three months. The White House coronavirus task force advised the president to reinstate inbound travel from Brazil, the EU, and the UK.
- New Mexico activated "crisis care" standards, which suspends all nonessential procedures and could eventually allow doctors to ration care based on patient viability. Daily deaths in California hit a record 220 and ICU beds fell below 1,500 for the first time.
  Virginia will implement a curfew and further on social gatherings after new daily cases broke records. Pennsylvania imposed new restrictions on gatherings, restricted school sports and closed indoor restaurant and bar service. Indiana surpassed 400,000 confirmed virus cases.
- **US President-elect** Joe Biden and Vice President-elect Kamala Harris were jointly named Time magazine's 2020 "Person of the Year." President-elect Biden tapped Susan Rice to head the White House domestic policy council.
- Attorney Generals from 17 states and over half of the House Republican caucus signed an amicus brief calling on the US Supreme Court to take up a Texas **lawsuit** that would overturn the results of the election. The Supreme ruled Thursday that federal agents can be sued for putting Muslim men on the no-fly list in alleged retaliation for failure to comply with counterterrorism investigations, and, separately, that there is no statute of limitations on when rape charges can be filed in the military.
- A website surfaced Thursday that accused **election officials** of "treason," publicizing photos and home addresses; US intelligence agencies are looking into the issue.

#### **Emerging & Existing Hotspots: Venezuelan Elections**

This past Sunday, the government of embattled Venezuelan President Nicolas Maduro declared victory in the country's parliamentary elections. Since January 2019, there have been competing claims to the Venezuelan presidency, with National Assembly leader Juan Guaido acting as the de-facto leader recognized by dozens of members of the international community, including the US and European Union.

With the results of last Sunday's election, in which less than 30 percent of registered voters went to the polls due to a nationwide boycott, Maduro's government has solidified control over all political institutions in Venezuela and dealt a massive blow to Guaido's oppositionist movement. This week, Guaido is holding a separate electoral referendum to reject the results of last Sunday's vote and determine their political path forward. Despite this, the opposition

leader and his allies will no longer be part of the parliament on January 5, when the new members of the National Assembly are sworn in.

Guaido's decision to boycott the election appears to have backfired from a strategic point of view as it will allow Maduro to consolidate power throughout the Venezuelan government. Some members of the international community have already appeared to move on, with cracks even showing among those who support Guaido - earlier this week, Spain's foreign minister referred to Guaido as "opposition *leader*" instead of interim president, despite the EU's decision not to recognize the results of the election. The US called the election "a charade" and has continued to implement sanctions on members of Maduro's government, as well as on the country's key economic sectors. Nevertheless, the results of the election will have significant short-term consequences in addition to the long-term stalemate playing out in the country. According to the Venezuelan constitution, commercial treaties and oil deals must be ratified by the National Assembly, which up until Sunday had been controlled by Guaido and his political supporters. Maduro will now be able to exert additional

influence over Venezuela's political and economic trajectory by passing budgets, signing international treaties, and signing deals with foreign companies.

Russia, China and Iran are among the members of the international community who continue to support the Maduro regime, and are likely to benefit from his unified control of the government. Despite an array of international sanctions on Venezuela's energy sector, growing links have emerged between Caracas and leadership in Beijing and Tehran. Just within the last week, Venezuela received its largest-ever shipment of fuel from Iran, which it has depended on to make up for crippling domestic gasoline shortages resulting from corruption and mismanagement. China continues to purchase Venezuelan oil in contravention of US sanctions, while also signing multiple contracts with Maduro for mining research and exploration, as well as other infrastructure-related development projects. Members of Maduro's government, including the Venezuelan Finance Minister, have called on private firms to sign trade deals with companies in the Middle East and Asia in order to circumvent US sanctions, while Maduro himself is seeking to finalize trade agreements with Turkey and Iran.

These developments will continue to pose headaches for the incoming Biden Administration, which will have limited options to affect change in a country that is already under a "*maximum pressure*" sanctions campaign. Transition advisers have stated that Biden does not plan to lift sanctions on Venezuela anytime soon, nor will he retract official US indictments of Maduro and key members of his government for narco-terrorism and drug trafficking. It is likely that the Biden Administration will seek to increase pressure on Caracas by coordinating more closely with allies in the region to support Guaido and the opposition, while also increasing the US's profile in South America more broadly. In any case, the political stalemate in Venezuela has begun to tip in Maduro's favor as a result of the December 7 elections, with increasingly limited options for the opposition movement and its supporters in the international community.

# State of the Transition: Electoral Deadlines, Cabinet Appointments and Expected Policy

December 7 marked the deadline for all 50 states to certify the results of their elections and confirm their electoral votes for the presidential race. Despite the race being over for several weeks, less than 30 congressional Republicans have acknowledged President-elect Biden's victory, while the attorneys general of 17 states are currently engaged in a lawsuit asking the Supreme Court for an emergency order to invalidate millions of ballots in four battleground states - Georgia, Wisconsin, Michigan and Pennsylvania

Although the Supreme Court is overwhelmingly likely to reject this bid, President Trump, his legal team, and political supporters throughout the federal and state governments are exhausting every possible legal recourse in an attempt to overturn the results of the election.

In the meantime, President-elect Biden has continued to name appointments to his cabinet and executive branch team. Over the past week, Biden has selected retired four-star general Lloyd Austin to lead the Pentagon, California attorney general Xavier Becerra to lead the Department of Health and Human Services, Congresswoman Marcia Fudge to be Secretary of Housing and Urban Development, former Obama chief of staff Denis McDonough to be Veterans Affairs Secretary, and former Agriculture Secretary Tom Vilsack to return to the same position. As expected, Biden's appointments are thus far mostly conventional and uncontroversial, although there does not appear to be a consistent ideological pattern across departments or agencies. The exception at this juncture is General Austin, who will need to be granted a waiver to lead the Department of Defense, as his recent retirement from the military falls within the seven-year period mandated by law to protect civilian leadership of the Pentagon. As a result, Biden has faced some pushback from across ideological spectrum, although Austin's confirmation is still expected to proceed smoothly. Biden has not yet selected anyone for the positions of Education Secretary, Labor Secretary, Commerce Secretary, or Attorney General.

# State of the Transition: Electoral Deadlines, Cabinet Appointments and Expected Policy

Upon taking office on January 20, President-elect Biden has signaled that he will take action immediately and sign a number of executive orders to reverse Trump Administration policies. To combat the worsening COVID-19 pandemic, Biden has said that he will ask Americans to wear masks for the first 100 days of his administration while Operation Warp Speed works to distribute the vaccine across the country. The former vice-president has established a coronavirus task force led by former surgeon general Vivek H. Murthy, while also asking Dr. Anthony Fauci to stay in his current capacity and become chief medical advisor to his presidency. In the short term, most political analysts expect the Biden Administration to focus overwhelmingly on the public health crisis and economic recovery, which may limit the presidential bandwidth for other legislative priorities.


On foreign policy, Biden has said that will keep campaign promises and use executive orders to rejoin the Paris Climate Accords and World Health Organization, repeal the ban on travel from some Muslim-majority countries, and reinstate the Deferred Action for Childhood Arrivals (DACA) program for children brought to the US illegally. The transition has been less explicit about future policy on issues such as tensions with Iran. Venezuela, China, and North Korea, although Biden's cabinet appointments, such as Antony Blinken at the State Department, have signaled a return to Obamaera baseline policies. In interviews, future National Security Adviser Jake Sullivan has conceded the successes of some Trump Administration policies in the Middle East, most prominently the Abraham Accords, which normalize diplomatic relations between Israel and some Arab neighbors. In the short term, Biden will also likely maintain the status quo with sanctions campaigns against Russia, Iran, and Venezuela. In Asia, Biden's selection of longtime China critic Katherine Tai as US Trade Representative indicates he intends to continue to be tough with Beijing on issues of tariffs and import/export rules. The key difference on foreign policy will be the Biden Administration's willingness to reengage with multilateral institutions and traditional allies around the world such as NATO, the WTO, and European Union - a dramatic departure from the "America First" approach of the last four years.

As of 2100 hours US EDT on December 10




### **Confirmed Cases (New)**


