WHEREAS, there are sufficient funds in the budget due to other vacancies in the County Attorney's Office.

NOW, THEREFORE, BE IT RESOLVED, that the Chairman of the Legislature be hereby authorized to execute a contract with Rachael Boruchowitz, J.D. for Child Protective Attorney Services for the County Attorney's Office at an hourly rate of \$100.00 per hour, not to exceed \$5,000, effective January 17, 2012 through December 31, 2012, on an as needed basis, funding available in the 2012 County Attorney budget account no. 1420.401, subject to approval by the Schuyler County Attorney.

DISCUSSION: Legislator Barnes is concerned about the rate of pay and the level of usage. Administrator O'Hearn stated that with the restructure of the office and a new full time Attorney as well as the qualified Assistant, they could very well cut back and may not even need to use Rachael contractually. However, there could possibly be a need for her to work on the NYCLU law suit that is still in process, or even bring one of the new Attorney's up to speed on this law suit. It would be at a minimum, if at all. He then suggested that a not to exceed dollar amount be added to the Resolution. Legislator Barnes said he could support a \$5,000 cap on this. Chairman Fagan said with the current salary schedule, we are running about \$8,000 under budget this year. This is because of no County Attorney salary or secretary salary being paid out of this year's budget yet. He also stated that with the County Attorney and a new Secretary not starting until February, they will see a \$10,000 savings. He would suggest that \$10,000 be the not to exceed amount. The Clerk suggested that the Legislature go with the \$5,000 figure, and it could always be increased if need be later. Legislator Halpin then wanted to know if they had a comparison of what they paid Attorney's from last year to this year. Chairman Fagan asked if this was outside counsel she was referring to. Legislator Halpin said yes. Administrator O'Hearn said he would supply Legislator Halpin with the past two years worth of history because of the transition with Attorney Coleman leaving. This year's would be lower than normal for sure. Vote 6-0.

Administrator O'Hearn explained that this is included as part of the report that we have on file. Legislator Barnes asked if this would include an educational check, and if a release had been signed. Administrator O'Hearn explained that the Civil Service Department takes care of all of this. They actually ask for, and have on file, proof of submission of transcripts. The also have a criminal, standard background, as well as professional references, on file. Legislator Halpin asked if they had anything in writing regarding what they will be paying for. Chairman Fagan stated that this should be a performance measure for the County Attorney's Office, for year end. He feels that with the level of expertise, they should be able to decrease the cost of outside counsel to the County. Administrator O'Hearn also added that the Department of Social Services is able to receive reimbursement for the salaries. Legislator Halpin asked if Mr. Rossi was bringing a Secretary with him. Administrator O"Hearn said no, he will have to conduct interviews. The Clerk said the last tabled Resolution from the organizational meeting was to appoint a secretary, which hopefully can be done at the February 13, 2012 Meeting.
