Global


Overnight, confirmed coronavirus cases grew to 67,454,385 in 216 countries and territories, with 1,542,894 deaths.


- A Spanish study found that individuals with elevated blood sugar levels once hospitalized with COVID-19 have a high death rate, regardless of whether they were diabetic.
- Chinese authorities have begun pushing theories that the coronavirus originated outside of China as they continue to face global anger over their initial mishandling of the virus.
- Scientists are studying hockey-related outbreaks hoping to find clues about the ideal conditions in which the coronavirus thrives. Experts speculate that ice rinks may trap the virus around head level in a rink that, by design, restricts airflow, temperature and humidity.

Global

Over the past week, the global curve for new cases flattened, while topping 67 million. One week ago, the count was 62 million. The US continues to be the global leader for new infections, reporting more than 200,000 new cases three times last week. India, Turkey, Russia and Brazil consistently reported more than 20,000 new cases a day.

The upward trend for global deaths continued, increasing an average 5 percent over the past 7 days.





COVID-19 Vaccine

Over the weekend, Russia started its Covid-19 vaccination program, with clinics in the capital Moscow inoculating those most at risk from the virus.

- With Europe exceeding 20 million confirmed coronavirus cases, in the UK, the first vaccine doses are set to be administered on Tuesday, with the National Health Service giving top priority to vaccinating the over-80s, frontline healthcare workers and care home staff and residents.
- Pfizer Inc applied for emergency use authorization of its coronavirus vaccine in **India** on Sunday. The Serum Institute of India, which is manufacturing the Oxford-AstraZeneca vaccine in the country, has also applied to Indian regulators for emergency use authorization. Doses of the Oxford-AstraZeneca vaccine could be available for private purchase in India at a cost of \$8 as soon as March.

- China's Sinovac Biotech has secured \$515 million in funding from a local firm to double production capacity of its coronavirus vaccine.
- Indonesia received 1.2 million doses of the Sinovac vaccine from China over the weekend.
- The leader of the US vaccine development initiative,
 Operation Warp Speed, said vaccinations may start to have
 an effect on infection counts for "the most susceptible
 people" in January and February.



Markets

London Stock Exchange Group FTSE Russell will delete shares of video security firm Hikvision and seven other Chinese companies from certain products after a U.S. order restricting purchase of their shares.

- World shares and other risk assets fell on Monday as growing risks of a no-deal Brexit that hit the pound hard and fresh Sino-US tensions offset bets over more fiscal and central bank stimulus in Europe and the United States. European shares fell in early trade following losses in Asia.
- Oil prices slipped from their highest levels since March as a continued surge in coronavirus cases globally forced a series of renewed lockdowns.



Business

Huawei has started investing in emerging Chinese chip companies in an effort to become self-reliant in semiconductor technologies in the face of US sanctions.

- US oil and gas producers have begun to follow their European rivals in setting ambitious targets on cutting their emissions amid mounting investor pressure over climate change; Pioneer Natural Resources, the biggest independent oil and gas producer in the Permian Basin, joined ConocoPhillips and Occidental Petroleum in pledging to cut greenhouse gas emissions.
- Cisco has agreed to buy London-based cloud communications software company IMImobile PLC for 595 pence per share in cash in a deal valued at about \$730 million, including debt.

- Moncler, the Italian maker of luxury puffer jackets, has agreed to buy **Stone Island** in a cash and shares deal, valuing its smaller rival at €1.15 billion.
- Société Générale is merging its two domestic retail bank networks, closing 600 branches and cutting €450m in costs.



Africa

 Islamist militants in Mozambique killed two dozen soldiers in an ambush in the north of the country. The jihadist group is targeting villages and towns in a bid to establish an Islamist caliphate.

 Madagascar is facing acute famine as the country has gone without rain for over a year.

 Mali's interim legislature on Saturday elected Colonel Malick Diaw, a member of the military junta that toppled President Keita in August, as its president.

- US President Trump has ordered nearly all US troops to withdraw from Somalia, part of a global pullback before Trump leaves office. The mission has been considered a cornerstone of the Pentagon's global efforts to combat al Qaeda.
- Ethiopian Prime Minister Ahmed denied that a guerrilla war Tigray People's Liberation Front from the mountains of Tigray has emerged.



Asia

- China's exports leapt by the most in nearly three years in November, in a sign of rising global demand for its goods.
- South Korea will impose heightened social distancing rules
 for the capital Seoul and surrounding areas, as authorities struggle
 to contain the nation's largest wave of coronavirus infection in nine
 months.
- Former Hong Kong lawmaker Ted Hui said on Sunday his local bank accounts
 appeared to have been frozen after he said he would seek exile in Britain to continue
 his pro-democratic activities.
- Japan sent nurses from Self Defense Forces to the island of Hokkaido and western metropolis of Osaka to
 help fight the outbreak as the winter cold is forcing residents indoors, spreading the infection.
- The rating agency S&P Global on Monday downgraded **Australia's** two most populous states, Victoria and New South Wales, from their AAA levels due to the fiscal impact of the coronavirus pandemic.



Europe

- The UK and the EU have agreed to make one final attempt to secure a post-Brexit trade deal, with talks resuming in Brussels on Sunday. Investment bank JPMorgan said odds of a no-trade deal exit had risen to one third from 20 percent.
- German industrial production grew faster than most economists had expected in October, fueling hopes that Europe's largest economy could avoid a double-dip recession in the coming months. Britain is working on a plan to take control of one of Britain's oldest steelmakers to secure the supply chain for the country's nuclear submarine fleet.
- Turkey has entered its first full weekend lockdown since May as deaths from coronavirus more than doubled in less than three weeks to hit record highs. Russia hit another daily record of new cases on Sunday, with 28,701 infections. Italy surpassed 60,000 deaths. Romania reported its 500,000th virus case over the weekend. Government officials will ease coronavirus restrictions in Portugal over the Christmas holiday, permitting domestic travel December 23 to 26.
- Romania's opposition Social Democrats (PSD) won Sunday's general election with just under 30 percent of votes in both houses of parliament, partial official results showed on Monday.
- France, Germany and Britain warned that Iran's announcement that it intended to install additional, advanced uranium-enriching centrifuges and end international inspections jeopardizes efforts to preserve a return to the JCPOA nuclear agreement and a return to diplomacy with the incoming US administration.



Middle East

The UAE was the target of cyber-attacks after establishing formal ties with Israel.

 Kuwaitis voted in legislative polls on Saturday with the Gulf state mired in its worst economic crisis in decades, with the outgoing parliament blamed for blocking reforms.

• **Bahrain** will not allow the import of Israeli goods produced in settlements in occupied Palestinian territory, disavowing comments made by the Gulf state's trade minister last week.

• Iran has instructed its oil ministry to prepare installations for production and sale of crude oil at full capacity within three months, anticipating an easing of sanctions under US President-elect Biden. Rumors are circulating that Iran's Supreme Leade. Ayatollah Ali Khamenei is ill and has transferred his duties to his son. Iran claimed the killing of its top nuclear scientist last month was carried out remotely with artificial intelligence and a machine gun equipped with a "satellite-controlled smart system."

Tunisia surpassed 100,000 infections.



Americas


Allies of Venezuelan President Nicolas Maduro on Sunday won a majority
of seats in parliament after scant participation in an election that the
opposition boycotted, saying it was a farce meant to consolidate a
dictatorship.


- Mexico's presidency has proposed tightening restrictions on "foreign agents" operating in the country, in a move that follows heightened tensions with Washington and is widely seen as aimed at US counternarcotics officials.
- An earthquake of magnitude 6 struck near the coast of northern Chile.
- Over the weekend, Canada surpassed 400,000 confirmed virus infections.



Americas

Brazil is facing a new wave of coronavirus infections, with the country twice reporting more than 50,000 new daily cases last week. While Brazil never adopted a national program to curb the spread of the infection, during the spring outbreak localities encouraged social distancing and face mask wearing. Health officials are warning that current attitudes discounting the dangers of the virus risk a mounting death toll. With 6.6 million confirmed cases, Brazil has the second highest number of fatalities in the world, 176,941.

Americas: US

- The number of people receiving hospital treatment for Covid-19 in the US rose to a new high on Sunday, 101,487, as the pandemic placed increasing strain on **the nation's healthcare system**. New Mexico Gov. Lujan Grisham is warning that she may need to take extreme measures by allowing hospitals to move to "*crisis standards*" and deliver care depending on a patient's likelihood of surviving. Tennessee Gov. Bill Lee has authorized National Guard troops to drive ambulances, test patients and perform nursing tasks to relieve stress on the overwhelmed health facilities. The CDC issued comprehensive COVID-19 mitigation strategy for states, including prioritizing in-person school.
- In California, the San Francisco Bay Area, southern California and the San Joaquin Valley locked down with stay-at-home orders on Sunday night. California topped 1.3 million cases over the weekend, New York, 700,000 and Pennsylvania and Tennessee, 400,000 each. The FBI raided a New Jersey coronavirus lab suspected of fake testing. The Arizona state legislature will close for the whole week after at least 15 current or future Republican legislatures may have been directly exposed to COVID-19 by meeting with Rudy Giliani, some without masks; Giliani tested positive over the weekend.
- At a campaign rally in Georgia, President Trump devoted considerable time in his remarks to allegations of **widespread fraud**, continuing decline to concede the race. A federal appeals court on Saturday rejected a bid to block President-elect Biden's victory in Georgia and left in place procedures that will make it easier for voters to cast **absentee ballots** in January for two Senate seats in a runoff.
- President-elect Biden has selected California Attorney General Xavier Becerra as his health secretary.
- The US ended five cultural exchange programs with **China**, calling them "soft power propaganda tools." The US is also preparing to impose sanctions on at least a dozen Chinese officials over their alleged role in Beijing's disqualification of elected opposition legislators in Hong Kong.



The Path Forward for US-Indian Relations

Asia remains a focal point as the transition a Biden Administration in the US continues and the president-elect's team works to develop and articulate a foreign policy vision. Although strategy on China looms the largest, deepening ties with India and their implications for US policy in the Indo-Pacific also warrants attention. In a recent policy discussion at a Washington think tank, two high-ranking US officials discussed the US perspective on the Indian relationship through diplomatic and defense lenses. Despite a stymied trade relationship and differences of opinion on Russia, the US sees deepening ties with India as an important component of regional alliances against Beijing and a potential destination for diversifying supply chains away from dependence on China.

The recent history of US-Indian ties has been one of consistent development of the relationship, a trend which is unlikely to reverse under incoming President Biden. The last four years has been marked by a deepening of both diplomatic and security ties: per Deputy Assistant Secretary of State for South Asia Laura Stone and Deputy Assistant Secretary of State for South and Southeast Asia Reed Werner, relationship is at its "best and most mature in recent memory." Stone reports that the US has conducted six high-level dialogues with India in the last two months, including the third iteration of the 2+2 ministerial, in which secretaries of both state and defense meet with their counterparts, and President Trump also conducted a high-profile and successful state visit last February, along

with several virtual and lower-level meetings. Defense ties have similarly deepened: in October, the US and India signed the Basic Exchange and Cooperation Agreement (BECA), a major defense pact to share satellite intelligence. Over the last four years, the US and India have conducted multiple joint exercises, including the inaugural Tiger Triumph naval exercise, and the US has approved large Foreign Military Sales to New Delhi, including advanced technology such as unmanned aerial vehicles.

Both Stone and Werner emphasized that the US-Indian relationship is increasingly built upon converging strategic interests in the region, which alludes to a growing shared understanding of China strategy. Indeed, throughout their comments, both officials projected a tone of unmitigated optimism that reflects India's increasing importance for US strategies to compete with China in the Indo-Pacific, in addition to genuine development in the relationship. Frequently considered a potential "counterweight" to China in the region, the US sees in India an opportunity to strengthen regional coalitions against Beijing as well as reduce supply chain dependence on China by developing India as an alternative manufacturing destination. A key element of this strategy is based on strengthening regional structures, rather than simply the bilateral relationship.

India has deepened its multilateral commitments, most notably to the Quadrilateral Security Dialogue between the US, India, Japan and Australia, commonly known as the Quad. In November, all four members of the Quad participated in the Malabar Security Exercises for the first time, signaling increased alignment on regional strategy and - the US hopes - more willingness to present a united front against China in the Indo-Pacific. India, for its part, has long had a tense relationship with China that has only intensified since the bloody border clashes in Ladakh this summer. Although India does not have the capacity to confront China either militarily or through economic measures, anti-China sentiment in the country is at a high: India has, to date, banned dozens Chinese apps from Indian marketplaces, including the popular app TikTok, and many Indians continue to call for a boycott on Chinese goods. Notably, India declined to join the Regional Comprehensive Economic Partnership (RCEP), the recently-negotiated Asian free trade agreement spearheaded by Beijing, based on Delhi's concerns about China.

Despite consistently deepening ties and converging strategic interests, the advance of US-India bilateral relations is not without impediments. Many questions of bilateral trade remain unsettled:

President Trump's visit to New Delhi in February was touted as an opportunity to establish a Phase I trade deal, but negotiations remain stalled. The trade relationship has been stymied since the US removed India's Generalized System of Preferences (GSP) status in March 2019; since then, the two countries have locked heads over reinstating GSP status, Indian price caps on medical devices, and what New Delhi calls US "anti-competitive practices" with regards to steel and agriculture subsidies. Analysts are cautiously optimistic, however, that further progress on trade talks could be made under President Biden. India's continued relationship with Russia is also a point of contention for the US. Russia has been a longstanding and consistent partner of India, and the two countries maintain a close defense relationship. A reported 60 percent of Indian defense technology is of Russian origin. The Russian technology presents both a diplomatic challenge - Russia also being a top US adversary and a legal one - extensive use of Russian defense technology potentially leaves India open to CAATSA sanctions by the US. Human rights issue, especially amid heightened internal religious tensions in India, are also a frequent concern for lawmakers in the US.

As President-elect Biden prepares to take office, he and his team will ultimately consider US-India strategy through the great power competition lens that has dominated American foreign policy in recent years. In that sense, US-India relations will not change dramatically: Washington will continue to cultivate the country as a counterweight to China in Asia, both as an opportunity to reduce economic dependence on China and as part of a broader coalition of likeminded nations able to unite diplomatically and militarily against Beijing.






Over the past week, the third wave of coronavirus produced record numbers for daily new infections, deaths and hospitalizations. The impact is uneven across the nation, with five states – California, Texas, Pennsylvania, New York, and Florida -- experiencing the brunt of the public health crisis, reporting more than 10,000 cases a day for much of the week. California reported more than 20,000 the past four days.


Change in new COVID-19 cases in the past week

Conditions are improving in the midsection of the country, where most states are either flattening their curves or seeing a reduction in the rate of new cases















As of 2100 hours US EDT on December 6




