# Global

Confirmed cases of coronavirus surpassed 103.4 million with 2.23 million deaths. January was the deadliest month of the pandemic globally, with over 400,000 deaths confirmed.

- Recent studies indicate that one quarter to one third of COVID-19 cases may be asymptomatic – but that even asymptomatic cases can have long-term health impacts.
- Business travel spending is forecast to grow 21 percent this year worldwide, helped by the rollout of COVID-19 vaccines, but will not recover to pre-pandemic levels until the middle of the decade, according to the Global Business Travel Association's BTI Outlook.



# **COVID-19 Vaccine**

Only a handful of the countries hosting millions of refugees and displaced people around the world have plans to inoculate them, which could leave a vulnerable population that would later pose a risk to any global recovery.

- A study by the Icahn School of Medicine at Mount Sinai found that people who have already had COVID-19 may need only one vaccine dose.
- Tanzania has no plans to accept coronavirus vaccines and will rely instead on herbal remedies and improved hygiene to fight infections, the country's health minister said this week.
- Philippines President Duterte accused the EU of holding vaccines hostage in a televised address; the country hopes to vaccinate two-thirds of its population this year.
- Although the EU has provided €70 million to six Balkan aspiring EU members to purchase vaccines, procurement problems in Europe mean that Kosovo, Bosnia and Herzegovina, North Macedonia and Montenegro have yet to receive any shots months after inoculation began in other countries. Frustrated, some are now looking east to Russia and China to secure scarce supplies.




# **COVID-19 Vaccine**

Globally, 98.99 million have received vaccinations.

Israel remains the global leader in vaccinating its population, with 35.6 percent receiving at least one dose. Despite this success, the country is seeing a spike in new cases, clustered in the ultra-orthodox community which eschews social distancing directives. Daily COVID-19 vaccine doses administered per 100 people, Feb 1, 2021

### Markets

# The dollar hovered near a seven-week high, benefiting from a euro selloff overnight after coronavirus lockdowns choked consumer spending in Germany.

- **Global stock markets** gained for a second day on Tuesday, spurred by increased optimism about economic stimulus and global recovery.
- **US markets** saw their largest gain in over two months, regaining grounds after last week's losses.
- **Silver futures** closing at an eight-year high Monday, as Reddit users discussed the possibility of another short squeeze.
- **Oil prices** rose more than 1 percent on Tuesday after major crude producers showed they were reining in output roughly in line with their commitments.



### **Business**

Facebook plans to roll out an in-app prompt showing users how their data is used, as the company battles Apple over new privacy changes that would require user consent to track their behavior.

- Ford plans to use **Google's** Android operating system for vehicle display screen starting in 2023.
- Applications for **life insurance** jumped 4 percent in the US in 2020.
- Amazon is poised to cap off its pandemic-fueled 2020 financial performance with record quarterly sales driven by a surge in online holiday shopping with people stuck at home.
- Exxon Mobil Corp. is forming a business unit that will focus exclusively on technologies to lower carbon emissions, as the oil giant faces increasing pressure to step up its sustainability investments.

- Robinhood raised \$2.4 billion in its second capital infusion in four days, giving the company finances to cover a surge in collateral requirements from turbulent trading of the past week. Robinhood's CEO is reportedly called to appear before a House committee on February 18.
- **BP** plunged to a \$5.7 billion loss last year, its first in a decade, as the pandemic took a heavy toll on oil demand, and the energy company warned of a tough start to 2021 amid widespread travel restrictions.

# Africa

- South Africa, where one of the more infectious new variants is thought to be prevalent, received its first shipment of vaccine from AstraZeneca. Former South African President Zuma announced that he will defy an order by Cape Town's top court to testify on corruption allegations.
- **Ugandan** opposition politician Bobi Wine filed a petition contesting the reelection of incumbent Museveni, calling the poll "*rigged.*"
- The UK announced its first sanctions against **Zimbabwe**, with asset and travel bans against four security chiefs over the deaths of 23 people during crackdowns in 2018 and 2019.






# Asia

- S&P Global expects **Asia-Pacific** growth of 6 percent this year, led by **China**, while corporate profits rebound but its mood is one of caution rather than exuberance.
- **Myanmar's** military said they would hold "*free and fair*" elections following the one-year state of emergency. The US threatened sanctions over Myanmar's military coup.
- **China's** top diplomat warned the **US** not to cross a "*red line*," as President Biden signals continuity with the previous administration on hot-button issues including Hong Kong and Xinjiang.
- Police in China broke up a criminal ring that had manufactured and sold more than 3,000 doses of fake coronavirus vaccine. President Xi said that intellectual property protection plays a central role in China's development strategy. Many places in China will suspend religious gatherings over the Lunar New Year holidays to precent COVID-19 outbreaks.
- Japan is set to extend a state of emergency in Tokyo and other regions for another month. Japan's health ministry will consider administering vaccines at workplaces once vaccines are widely available.
- India unveiled a new budget that includes a proposal to more than double health care outlay and raise the ceiling for FDI in the insurance sector. Twitter temporarily blocked access to accounts of some Indian politicians and activists criticizing new agricultural laws.
- Indonesia surpassed 30,000 coronavirus deaths, the second highest after India in Asia.

# Asia

Myanmar (Burma) is recovering from the December outbreak of coronavirus, with restrictions still in place for much of the country, including a stay-at-home order, nightly curfew and closure of non-essential businesses. Total infections exceed 140,000 and deaths 3,000. Myanmar began vaccinating citizens in late January, receiving donations of vaccines from India and China.

# Europe

- The eurozone economy shrank 0.7 percent in the final quarter of last year, less than most economists had expected. Portugal saw a tourism drop of more than 60 percent last year. France's top football league (LFP) failed to resell TV rights for the 2021-2024 season.
- **French** President Macron signaled that he intends to reduce the French military force in the **African Sahel**.
- **Turkish** President Erdogan said that his party may begin work on a new constitution.
- The EU's police agency on Monday warned travelers to watch for organized crime gangs selling fake COVID-negative certificates at airports, sometimes for as much as 300 euros each. Chancellor Merkel said Germany remains on track to vaccinate every citizen by the end of the summer. The European Commission said EU member states are in the "*big league*" of vaccinating countries, having now inoculated 12 million. Spain, Germany and Austria all offered medical assistance to Portugal as the country's hospitals continue to struggle under surging cases. About half of new cases in the Netherlands are due to new, more contagious variants. Britain began door-to-door COVID-19 testing of 80,000 people in a bid to stem the spread of a new highly infectious South African variant.

# Middle East

- Lebanese Hizballah said that they had shot down an Israeli drone in their airspace; Israel said that it had fallen. Lebanon raised the price of subsidized bread by a fifth amid an ongoing fiscal crisis.
- Iran tested a new rocket on Monday, part of a government-backed program to send civilian satellites into orbit 310 miles above ground; analysts assess testing is related to military research to develop ICBMs.
- **Israel** said that it had delivered the first of 5,000 vaccine doses earmarked for Palestinians to the **Palestinian Territory**, following controversy over Israel's decision not to provide vaccine to Palestinians.
- **Tunisia and the Palestinians** will receive their first doses from the Covax facility this month.
- Israel and Kosovo formally established diplomatic relations.
- At least three people were killed and seven wounded in a series of explosions in **Afghanistan** on Tuesday as the US and NATO consider withdrawing their forces from the country by May.



### Americas

- Mexico ramped up vaccine procurement plans, saying it will receive Oxford-AstraZeneca vaccines from the Covax facility this month. Though Mexico was the first Latin American country to begin vaccinations on Christmas Eve, it has fallen behind schedule.
- **Brazil's** Congress chose lawmakers endorsed by President Jair Bolsonaro as speakers of its two chambers, giving the far-right leader a base among center-right politicians with whom he had once vowed never to ally. Bolsonaro's stronger standing in Congress should dispel for now the growing clamor for his impeachment from critics who have filed 60 requests to unseat him.
- **Haiti's** President Moise proposed constitutional amendments that would allow members of the country's diaspora to run for high-level office.
- **Canada's** northern territories have achieved much higher COVID-19 vaccination rates than its more populous provinces despite geographic challenges in a sign that prioritizing vaccine rollout in indigenous and rural communities is paying off.



# **Americas: US**

- The Congressional Budget Office estimated that the US economy will return to its pre-pandemic size by the middle of 2021, faster than expected, but will not recoup lost jobs until 2025. US manufacturing growth decelerated in January, even as employment strengthened. Multiple Federal Reserve officials called for "aggressive" fiscal aid. Democratic Congressional leaders released a \$1.9 trillion COVID-19 spending blueprint ahead of President Biden's meeting with Republican leaders, who were expected to present a scaled-down version of the bill.
- Over 26.2 million Americans have received at least one dose of vaccine, outpacing the country's total number of COVID-19 cases; 5.9 million people have received both doses of vaccine. The CDC said that efforts to detect mutations in the US has increased "*tenfold*," although experts say it is still not sufficient. New CDC data showed that African Americans are being vaccinated more slowly than white Americans. The administration promised undocumented migrants the same access to vaccines as other civilians and said inoculation centers would be immigration enforcement-free zones. New York postponed vaccine appointments for the second day due to a storm on the east coast. New Jersey surpassed 700,000 infections.
- President Biden reinstated a 10 percent duty on aluminum imports from the UAE that President Donald Trump removed just one day before leaving office. The move casts a pall over the hopes in the business sector in the US. and in Europe that Biden would roll back the **tariffs** that Trump put on **steel and aluminum imports**.
- The Pentagon and NASA removed decades-old barriers between civilian and military space projects.

### **Emerging and Existing Hotspots: A Military Takeover in Myanmar**

As State Counsellor Aung San Suu Kyi and her once-banned National League for Democracy (NLD) prepared to begin their second term in office on Monday, Myanmar's military detained Suu Kyi and other NLD politicians in early morning raids, seizing power in a coup that returned the fledgling democracy to military rule. Under the leadership of Senior General Min Aung Hliang, the military declared a one-year state of emergency, saying the detentions and takeover were in response to election fraud and threats to national unity.

Following its initial detentions of NLD politicians, the military consolidated its power by removing 24 and appointing 11 replacements. As the coup occurred, internet and phone services were disrupted, Yangon airport was shuttered, TV channels went off air, banks reported being forced to close, and soldiers blocked roads in the capital. Many Burmese citizens have stocked up on supplies and hunkered down in their homes, as the turmoil of the military takeover continues to unfold.

Monday's coup came after weeks of tensions between the military and the NLD-led government following November 8 parliamentary elections, in which the NLD won a landslide 83 percent of seats while the military-backed opposition Union Solidarity and Development Party (USDP) was routed. The military insists that voting *"irregularities"* and fraud must be *"resolved according to the law,"* 

with the state of emergency declared in order to "*perform scrutiny of the voter lists and take action.*" The country's election commission denies that any errors occurred that could have caused the election to be discredited, and the military itself has not yet specified whether "*irregularities*" were substantial enough to have changed the election outcome. The military has said that after the one-year state of emergency, the country will hold a "*free and fair*" election - a claim that has been met with skepticism, though it could yet prove an exit ramp for the military leadership.

Though the USDP performed badly in the 2020 election, the military still held significant power in the democratic government. The military describes itself as the guardian of national unity and Myanmar's constitution, which the military helped write a decade ago, giving itself control over key security appointments and 25 percent of

parliamentary seats directly appointed by the armed forces – a percentage that gives it veto power over any fundamental changes to the country's power balance or constitution. In fact, many analysts believed a coup was unlikely precisely because the military's interests were so embedded in the existing constitution. Now, the military's motives and long-term plans, remain a source of uncertainty. Some have speculated that General Min Aung Hliang is acting to protect his own political and business interests after the NLD's resounding election win ruled out a successful future in politics.

Beyond the one-year rule declared through the state of emergency, the country's path forward remains uncertain. Following a landslide victory for the NLD and the detention of Suu Kyi, who is widely popular in Myanmar, military leaders will face popular backlash, making a voluntary return to democratic power-sharing improbable – despite the military's pledge to hold elections. Suu Kyi has urged her supporters to "*protest against the coup*," but thus far major protests have yet to break out. Getting information from within the country has been difficult given internet and phone service disruptions, but some pro-democracy activists have shared concerns that any protests

would be used by the military as an excuse for wider crackdown. Moreover, Myanmar has experienced the worst of its COVID-19 cases over the past several months, prompting strict quarantine measures and heightened fears over the country's lack of health care capacity to handle a severe outbreak.

Foreign governments and organizations have condemned the coup, with the US, UN, Japan, and European leaders reacting strongly. India has expressed concern, reiterating that New Delhi has always supported Myanmar's democratic transition. China issued a relatively ambiguous statement urging continued stability, but analysts believe policymakers in Beijing to be extremely uneasy with the military takeover, given China's good relations with Suu Kyi's coalition. Meanwhile, some closer neighbors like Thailand and Cambodia have called the coup an internal matter, seeking to avoid taking sides. Beyond statements, international action is likely to come in the form of sanctions - something the Biden Administration has already threatened. Human rights organizations have warned the coup could make Myanmar once again treated as a "*pariah state*" by the international community.

### **Emerging and Existing Hotspots: A Military Takeover in Myanmar**

For the country's persecuted Rohingya minority, a government fully controlled by a military that stands accused of ethnic cleansing threatens to worsen an already dire situation and delay the repatriation of hundreds of thousands of Rohingya in Bangladesh. The UN Security Council will meet today to address the developments in Myanmar and is expected to focus on the plight of the Rohingya. In the past, however, Russia and China have shielded Myanmar from any significant Security Council action.

As the outlook for Burmese democracy looks increasingly bleak, trade experts and corporate leaders have begun warning of the coup's economic and business impacts. Under Myanmar's democratic transition, foreign investors gained interest in the country, particularly in Asian neighbors including Japan, China, and Singapore. On Monday, bank closures, internet and phone service blackouts, and transportation restrictions caused a multitude of business operations disruptions, prompting a wave of statements from companies across the region. However, the larger risk to Myanmar's economic ties is the likelihood of international sanctions, namely from the US. How the coup will impact economic ties with China, Myanmar's biggest trading partner, remains to be seen.

Though China's stated reaction was muted relative to western countries, Beijing's relations with the military are not as close as its ties with Suu Kyi's government, and the possibility of international sanctions is likely to sour Chinese business interests in the country. Already muted US and Western investment interest in Myanmar will further dissipate, and many western multinationals are expected to pull out of the country or relocate supply chains. Over the coming weeks, international reactions to the coup will become clearer. But beyond sanctions and pressure, little is expected from foreign governments already consumed with their own crises.

As of 2100 hours US EDT on February 1, 2021




### **Confirmed Cases (New)**


