# JUDGMENTS

# Australia. High Court

5 April 2016 - Medical Board of Australia v Broadbent [2016] HCASL 22 - Special Leave Application

# Australia. Federal Court

## 1 April 2016 - Primary Health Care Limited v Commonwealth of Australia [2016] FCA 313

In 2009, after approximately five years of operation, Primary Health Care Limited (PHC) applied to register the name "Primary Health Care" as a trade mark. The Commonwealth opposed the application on the grounds that the mark did not actually distinguishing the services, the use was contrary to law, and the mark was likely to deceive or confuse. These are grounds for objection under sections 41 to 43 of the Trade Marks Act.

In relation to the mark's ability to distinguish, the court examined the nature of the services PHC provided. PHC argued that, as the mark was to be used and interpreted by medical professionals in a private medical context, this was sufficiently narrow to enable services to be distinguished. However, the Commonwealth argued that PHC performed many services, and not just for doctors but other health professionals and the public. This diversity of markets in which PHC operated and the broad audience for the mark meant it was not capable of actually distinguishing the services provided and was merely descriptive.

The Commonwealth then argued that, in light of the people who might rely on the mark, exclusive use of it would be likely to cause confusion or mislead contrary to the Australian Consumer Law. People might assume that PHC was responsible for the all the services and actual health care in every centre bearing the mark, which was inaccurate. Ultimately, the Commonwealth was successful on all grounds and registration of the trade mark "Primary Health Care" was refused.

## New South Wales

## 6 April 2016 - Fan v South Eastern Sydney Local Health District [2016] NSWCA 64

Mr Fan presented to three different hospitals complaining of abdominal pain and vomiting. He was subsequently diagnosed with an inflammation of the bile ducts combined with the presence of gallstones. During this time he had a successful endoscopic procedure but three months later he underwent a cholecystectomy to remove his gallbladder. Mr Fan argued that not only did the original diagnoses fail to include acute cholecystitis which would have prompted a more timely cholecystectomy, but that the hospitals breached their duty of care to detect other health concerns, which led to a series of subsequent injuries.

The court looked at what was required of the hospitals from a clinical practice perspective, finding that the treatment Mr Fan received was correct for the original diagnoses, regardless of whether there was then a need to reassess and re-diagnose. The hospitals were found not to be at fault for rescheduling his operation for valid reasons, even after the cholecystectomy was clinically advised. In relation to the failure to detect other clinical indicia that led to different problems, such as the hospitals' alleged failure to identify his high blood sugar levels meaning his diabetes diagnosis was delayed, the court dismissed Mr Fan's complaints. The hospitals were not subject to a higher standard of care and, in the absence of further concerns raised by Mr Fan at the time, were not required to test for anything that was not exhibiting symptoms. The routine testing regime, such as the random glucose readings, was proper medical practice.

The complaints related to various interactions with the Claimant which the complainant characterised as "grooming"; these included the Claimant's praying with the junior worker and the laying on of hands, giving a book to that worker, which concerned the conversion to Christianity of a Muslim woman, and inviting her to various services and events at the Claimant's Church. The Respondent had investigated the complaints under its disciplinary procedure and had found the Claimant guilty of serious misconduct, namely the blurring of professional boundaries and the subjection of a junior colleague to improper pressure and unwanted conduct. The Claimant was given a final written warning, reduced on appeal to a first written warning.
