3. Order the Petitioner to pay a reasonable amount as and for child support to the Respondent in accordance with applicable guidelines;
4. Award the Petitioner his reasonable attorneys' fees and costs in this matter should it be contested by the Respondent; and,
5. Award such other and further relief as it deems just.
