### Post-Election Analysis and the 78th Legislative Session

Republicans far outpaced expectations on election day converting what had been forecasted to be a lackluster election year into one of historic proportions. Nevada Republicans have not held control of both legislative houses and the Governor's mansion since 1929 and have never, in the history of Nevada, held control of the legislature, the Governor's office, and all remaining constitutional offices.

Republicans won all three high-profile Senate contests by double-digit margins leaving Republicans with a 11-10 majority in the Nevada Senate. Not to be outdone, the Assembly Republican Caucus took the majority in the Nevada Assembly, dramatically reversing the previously held Democratic near-super majority. Democrats lost every assembly battleground seat. Most surprising was the loss of former Democratic Assembly Assistant Minority Leader, Assemblyman Jason Frierson, who lost his seat despite a 15 point democratic advantage. With a 25-17 majority, Republicans will control the Nevada Assembly for the first time since 1985. Democrats did not fare any better at the constitutional level losing every office, some by double-digit margins.

Many inside and outside of politics are asking how Republicans turned a swell into a crimson wave? Much of the rationale for understanding the results of the election have been known for months. Democrats were saddled with a president who is highly unpopular and now a lame duck. In addition, Democratic voting blocs have historically lower turnouts in mid-term elections when the White House is not in play. Nevada Democrats failed to field any candidate to oppose Republican Governor Brian Sandoval and the presence of a tax ballot initiative that would have been toxic for business drove traditionally Republican allied voters to the polls. The "why" and "how" of the election will certainly be dissected and will continue to be the product of speculation over the coming months.

To help inform your post-election thinking, below we provide a recap of the election results, outline the emerging leadership of the 78th Nevada Legislature and pertinent deadlines that will affect your ability to navigate the next legislative session.

### **Session Outlook**

The 78<sup>th</sup> session of the Nevada Legislature will convene on Tuesday, February 2, 2015, for the first legislative session of Governor Brian Sandoval's second term. In the Senate, Senator Michael Roberson has been elected majority leader and Senator Ben Kieckhefer has been elected assistant majority leader. On the Democratic side, Senator Aaron Ford has been elected minority leader. In the Assembly, Assemblyman Ira Hansen has been elected Speaker designate and Assemblyman Paul Anderson will serve as Assembly majority leader. On the Democratic side, Assemblywoman Marilyn Kirkpatrick has been elected minority leader.

In terms of legislating, the dramatic shift of political power will signal an entirely different 78<sup>th</sup> legislative session than previously envisioned. Previously submitted committee bills are now questionably relevant given the wholesale change of leadership in all committees. Moreover, all interim committee work was led by Democrats, leaving the validity and value of their recommendations unknown.

Time still marches on and the legislative session quickly approaches. It is important to be mindful of critical deadlines as the session unfolds:

- December 10, 2014: Deadline by which newly elected Assembly and Senate members may request a Bill Draft Request ("BDR"). After this deadline members will have only one (1) more BDR available to request.
- February 2, 2015: Commencement of the 78<sup>th</sup> Legislative Session, Nevada Legislature.
- February 2, 2015 February 9, 2015: Between these dates Incumbent and Newly elected Assembly
  members will have one (1) BDR request remaining to use. Between those same dates Incumbent and
  Newly elected Senators will have two (2) BDR requests remaining to use.
- February 2, 2015 February 16, 2015: Standing Session Committees deadlines to request BDRs.
   Joint Rule 14 (2013) allocates 50 per house.
- March 16, 2015: Deadline for Legislator bill introductions.
- March 23, 2015: Deadline for Committee bill introductions.
- April 10, 2015: Committee Passage, First House.
- April 21, 2015: First House Passage.
- May 1, 2015: Economic Forum report due.
- May 15, 2015: Committee Passage, Second House.
- May 22, 2105: Second House Passage.
- June 1, 2015: Sine Die.
