What is Realtime Court Reporting?

Realtime court reporting is the instantaneous translation of the stenographer's notes into English. Realtime court reporting sessions can also be setup to connect with state-of-the-art [Internet depositions](#), which allows for a live transcript and video feed to be streamed over the Internet to remote participants.

Why Realtime Court Reporting Is Important for Attorneys?

Realtime court reporting is a powerful tool for [depositions](#). With realtime, there is no waiting for transcript turnaround to view the testimony in your case. Instead, attorneys can view the record instantaneously, allowing them to search for keywords and highlight specific passages or mark important testimony for later review. Realtime also gives attorneys the ability to impeach live testimony; with a rough transcript in front of them, attorneys can challenge a key point or ask for clarification of a statement.

Also, the live feed aids the comprehension of the testimony as it happens. If the sound quality in the room is bad or if certain participants mumble or have accents, the court reporter (who is trained to be sensitive to these things) will take down the record, which can be immediately translated onto the screen so that everyone in the room can understand the testimony.

Realtime court reporting has benefits beyond the proceeding, as well. Colleagues can be kept informed of the developments in the case by copy and pasting portions of the transcript into e-mails for review and additional research. Synchronized with video, the draft can be viewed as a closed caption program, making it easier to search and locate the exact point at which a topic was discussed for later use. The ability to clarify the proceedings and organize case-related materials is what makes realtime court reporting so efficient: with it, attorneys can avoid the additional time, expense, and hassle of a secondary deposition.
