Global

Global infections blew past 93 million, growing at just under 1 million a day. As of yesterday, 35.25 million people have been vaccinated.

- Chinese health experts predicted that the global COVID-19 death toll could reach 5 million by March, and that 2021 could prove worse than 2020 for the pandemic's impact.
- After multiple delays, most of the WHO team arrived in Wuhan to investigate the origin of COVID-19, but two remain in Singapore after testing positive for COVID-19 antibodies.
- A group of 22 former officials from countries including Germany, India, Brazil, South Africa and Ireland have asked the G20 to launch an initiative to deliver bilateral, multilateral and private sector **debt rel**ief for poor countries battling the economic impacts of the coronavirus pandemic.




COVID-19 Vaccine

COVID-19 vaccination doses administered per 100 people, Jan 15, 2021

COVID-19 Vaccine

People across the world are generally likely to say yes to getting a COVID-19 vaccine but would be more distrustful of shots made in China or Russia than those developed in Germany or the United States, per an international poll.

- A coalition of technology companies including Microsoft, Oracle and Salesforce are developing digital vaccine credentials to enable people to easily share vaccination status with airlines, employers, and other businesses.
- India plans to use an app called CoWIN to be the "backbone" of its massive vaccination campaign.
- The WHO announced that Africa should receive its first doses via the Covax facility in March.



Markets

The S&P 500 is on track to end the week with losses as investors worry that new stimulus plans will lead to higher taxes.

- Global shares stumbled on Friday as hopes of a fiscal boost provided by a \$1.9 trillion US stimulus plan were smothered by the prospect of stricter lockdowns in France and Germany and a resurgence of COVID-19 cases in China.
- **US stocks** hit a record high Thursday before losing ground in afternoon trading.
- Speaking at a virtual Princeton University event, Federal Reserve Chairman Powell sought to reassure investors that the Fed is far from considering an "*exit*" from its **asset purchasing programs**, emphasizing that the central bank would continue clearly communicating its plans.



Business

The Trump Administration added nine companies to a military-linked blacklist, including plane maker Comac and phone maker Xiaomi; a state department official said that the US is unlikely to add further companies before January 20.

- Semiconductor companies are facing a demand surge, causing shortages for some chips, rising prices, and delays in filling orders that could eventually lead to consumer delays and possibly higher prices for new cars and some electronic devices.
- **Toyota** will pay \$180 million to settle a US Justice Department complaint over delayed emissions defect reports.
- **Toyota and Honda** have shut down multiple plants in Malaysia due to new lockdown measures.

- Airbnb's CEO predicted the pandemic will permanently change travel, with increased trips to small cities and longer periods spent visiting friends and family.
- Thousands of businesses should be covered by their insurance for losses caused by coronavirus lockdowns, the UK Supreme Court ruled on Friday, in a victory for industry regulators against major insurance companies.

Africa

- Three UN Peacekeepers were killed and six wounded in an attack in **Mali** by unidentified militants.
- Twenty-one hostages kidnapped by militants in Cabo Delgado,
 Mozambique, were rescued. Mozambique imposed stricter coronavirus rules, including closing bars and gyms and limiting gatherings to 30.
- Forty-six civilians are feared dead after an attack by suspected Islamist militants in **Democratic Republic of C**ongo.
- The UNHCR said there have been major human rights abuses in refugee camps in **Ethiopia's** Tigray region.





Asia

- **New Zealand** will loosen its strict border controls to allow 1,000 international students back into the country in April.
- **Philippine** journalist Maria Ressa, whose case has prompted international criticism of her country's crackdown on press freedom, now faces a third libel charge.
- In **South Korea**, a missionary school south-east of Seoul is under fire after health officials traced over 700 cases to it.
- Japan's ruling party urged Prime Minister Suga to extend the country's entry ban on nonresident foreigners through the Lunar New Year holidays. The opening of Osaka's Nintendo theme park was again delayed by COVID-19.
- North Korean leader Kim Jong Un offered a sneak peek of Pyongyang's pipeline of military hardware with unusual detail during a rare Workers' Party Congress meeting that ended this week, saying that the country is developing military drones, a nuclear-powered submarine and surveillance satellites, and that the missiles will get smaller and lighter, and fly farther.

Europe

- France tightened border controls and lengthened the overnight curfew nationwide. The UK banned travel from Latin America and Portugal over fears of a new variant. Germany surpassed 2 million virus infections and Sweden marked a grim milestone of 10,000 deaths.
- Europe's top human rights court agreed to examine Ukrainian allegations of Russian human rights abuses in Crimea. As opposition activist Alexei Navalny heads back to Russia this weekend, commentators call for western nations to be ready with sanctions if he is arrested.
- A **Swedish** court has dismissed an appeal by Huawei against its exclusion from the country's 5G network roll out, paving the way for the 5G spectrum auction scheduled for next week to proceed as planned.
- In a world of near zero inflation, **Turkey** stands out with annual consumer prices climbing to 15 percent, second only to **Argentina** among emerging markets and by far the highest in the OECD, with soaring food prices starving economic rebound.
- The **UK** economy shrank less than expected in November as output growth in the manufacturing and construction industries partially compensated for a milder contraction in the services sector.

Middle East

- Lebanon entered a strict lockdown, including a 24-hour curfew and shuttering most businesses.
- **Tunisia** imposed a four-day lockdown and overnight curfew amid a case surge.
- Saudi Arabia will not return to in-person instruction for at least 10 weeks.
- UN officials urged the **US** to reverse its terrorist designation for the **Yemeni** Houthis, citing humanitarian impact.
- **Oman** is seeking to sell \$750 million worth of bonds on the international debt market following a COVID-19-related budget shortfall.
- Dozens of **Sudanese** protested in the capital, Khartoum, for the closure of illegal detention centers run by a paramilitary organization implicated in Darfur.


Americas

- Local health systems are near collapse in Brazil's Manaus, where oxygen shortages are leading patients to be flown out of state, while others have suffocated on ventilators. Doctors report having to choose which patients to treat.
 Venezuela has agreed to send oxygen to Brazil.
- **Mexico** set a new record for coronavirus infections on Thursday, with 16,460 new cases confirmed by authorities.
- Regional governments in **Central America** are using COVID-19 test requirements to restrict groups of migrants passing through their borders.
- **Caribbean** tourism officials are rushing to increase COVID-19 testing capacity after the **US** became the latest country to require nearly all arriving passengers to present a negative test within 72 hours of departure.
- **Canadian** Prime Minister Trudeau urged nations around the world to maintain a unified front against **Chinese** detention of foreign nationals.



Americas

Uruguay is experiencing a strong outbreak of coronavirus, with new infections increasing at an average 7-day rate of 20.61 percent and deaths at 17.50 percent. Uruguay had successfully avoided earlier waves slamming Brazil and Argentina. The government acted fast, shutting down all public events and potential centers of gathering such as bars, churches, and shopping centers, along to border, asking citizens to stay at home. Uruguayan scientists developed their own PCR test and launched an impressive testing campaign, currently testing around 5,000 people a day. The government imposed new restrictions in mid-December but the new case rate has yet to flatten.

Americas: US

- President-elect Biden called for a \$1.9 trillion package headlined for its coronavirus relief but including billions in spending for cybersecurity, transit, wages, health care and other progressive programs. House and Senate leaders Pelosi and Schumer pledged quick action on moving forward Biden's stimulus plans.
- US weekly jobless claims rose to their highest level since August at 965,000. US airports expect to lose \$40 billion in revenue over two years due to the pandemic. The Trump Administration raised over \$4 million Thursday in its final auction of oil and gas drilling leases on federal lands.
- President-elect Biden plans to tap former Senate candidate Jamie Harrison to lead the DNC; Laura Rosenberger, a State Department and White House veteran, will serve as senior director for China; and David S. Cohen as deputy director of the CIA. Presidential candidate Andrew Yang announced his bid for New York City mayor.
- In court filings, the FBI state that the intent of the Capitol rioters was to capture and assassinate elected officials in the US government. Analysts say social media moves to cut off right-wing extremism has driven moves to encrypted messaging apps Telegram and Signal, as well as niche websites like Gab.
- Across the nation, 11.1 million Americans have been vaccinated. Twenty-two states have moved toward using age as the main criteria for prioritizing inoculations, with four more set to follow next week. Others are adhering to strict guidelines meant to assure that scarce coronavirus vaccine supplies went first to healthcare workers, nursing home residents and first responders.

State of the Transition: Impeachment & Inauguration Security Risks

In the wake of the deadly Capitol Hill riots on January 6, President Donald Trump was impeached by the House of Representatives this week in an historic bipartisan vote. The vote on Wednesday, which represented the first time a US president has been impeached twice, alleged that Trump incited a violent insurrection against the US government. The issue will now move to the US Senate as early as January 19

Outgoing Majority Leader Mitch McConnell has declined to bring the upper chamber back into session immediately to conduct the trial, meaning that hearings will take place in the early days of Presidentelect Biden's term. Should President Trump be convicted by a twothirds majority in the Senate, it would legally prohibit him from running for federal office in the future. Some believe that this is the true motivation for moving forward with impeachment, as Trump is known to harbor presidential ambitions in 2024. As it stands, the impeachment trial of President Trump will be an immediate priority for the next Senate Majority Leader, Chuck Schumer.

Meanwhile, President-elect Joe Biden has finalized and announced his appointments for Cabinet and executive leadership team. On Monday, Biden announced that William Burns, a highly-respected career State

Department official, will be his choice to lead the CIA. In selecting Burns, Biden continued his trend of selecting highly experienced career professionals with whom he has a longstanding relationships for top jobs in his Administration. The two men have worked together for decades on foreign policy issues dating back to before the Obama Administration, when Biden chaired the Senate Foreign Relations Committee. As with most of the President-elect's other picks, Burns's announcement was met with praise from the national security and intelligence communities. Secretary of State nominee Antony Blinken, Secretary of Homeland Security nominee Alejandro Mayorkas, alongside Pentagon chief designate General Lloyd Austin and DNI Avril Haines round out Biden's national security team, all of whom are expected to easily pass Senate confirmation in the next two weeks.

State of the Transition: Impeachment & Inauguration Security Risks

Nevertheless, some concern remains about the delays in scheduling these confirmation hearings, which are a result of Majority Leader McConnell's decision to keep the Senate out of session until January 19 - an unusual move, and the first time in a least 10 presidential transitions where the incoming president's nominees for a national security position will not have had a confirmation hearing at least 24 hours before Inauguration Day. In an already truncated presidential transition marred by delayed communications and coordination efforts between outgoing and incoming national security teams, the US remains in a high-risk period for the short to medium term as the Biden Administration gets up to speed.

Concurrently, domestic security tensions remain high particularly in Washington, DC and state capitols around the country in the wake of the January 6 attacks. FBI intelligence sources have indicated that further violent demonstrations may be planned on or around Inauguration Day on January 20, leading the Secret Service and federal law enforcement agencies to launch unprecedented security mobilization efforts. More than 15,000 National Guard troops will be in the nation's capital before the inauguration, outnumbering the current

number of troops abroad. Over the next several weeks and through the Biden Inauguration, the risk of domestic terrorism will be elevated, particularly around state and national government buildings. Although law enforcement officials are expected to make hundreds of additional arrests as a result of the January 6 violence at the Capitol, many extremists and domestic terrorists have not been disincentivized from political violence. Even in a pandemic environment where in-person attendance for the inauguration is expected to be low, the security risks will be significant in Washington, DC and around the country as we approach January 20.



Vaccine R&D Timeline

A total of seven vaccines are now available for public use, in limited quantities, in dozens of countries. These make up the leaders of the 230 vaccine candidates under development, per the WHO count.

The Johnson & Johnson (J&J) vaccine is the most recent to see positive results in Phase 1/2 trials conducted with 805 patients age 18 and older. More than 90 percent of participants made immune proteins, called neutralizing antibodies, within 29 days after receiving the shot, according to the company's report, and all participants formed the antibodies within 57 days. The immune response lasted for the full 71 days of the trial. The one-shot vaccine generates more neutralizing antibodies than a single dose of other front-runner COVID-19 vaccine, all of which are twoshot regimens. But when compared with two shots of these rivals, the response to J&J's single shot is in the same range. The company expects to get definitive efficacy data from a final-stage study by early next month, potentially leading to regulatory authorization by March.


Novavax launched phase 3 trials of its vaccine in the UK in September. Results are expected in early 2021. A larger trial in the US, which has provided \$1.6bn of government funding to the company, is expected to start this month.

Vaccine R&D Timeline





As of 2100 hours US EDT on January 14, 2021




Confirmed Cases (New)




