Global

Confirmed coronavirus cases rose to 104.8 million with 2.28 million deaths, continuing the downward trend in daily new infections and deaths.

- Nigeria's Ngozi Okonjo-Iweala is a step closer to becoming director-general of the WTO after South Korea's candidate quit the race following months of uncertainty over the body's leadership.
- Egypt has been elected to chair the 15th session of the UN Peacebuilding
 Commission for the first time, succeeding Canada.



COVID-19 Vaccine

Johnson & Johnson has filed an application seeking emergency use authorization for its COVID-19 vaccine with the US Food and Drug Administration, bringing the company one step closer to getting the first single-shot vaccine distributed in the US.

- In Israel, cases of COVID-19 and hospitalizations have dropped dramatically among people who were vaccinated within just a few weeks, with early data suggests that the vaccines are working nearly as well in practice as they did in clinical trials and suggesting that vaccines might even have the **potential to slow transmission** of the virus.
- British researchers are to explore mixing doses of the Pfizer and AstraZeneca COVID-19 vaccines in a world first trial aimed at finding new ways to swiftly reduce coronavirus infections as new mutated variants emerge.

- The US FDA announced it is planning a rapid review process for quick turnaround of new COVID-19 booster shots if variants of the coronavirus emerge against which the vaccines do not provide protection.
- **Pfizer Inc** said on Friday it had withdrawn an application for emergency-use authorization of its COVID-19 vaccine in India, after failing to meet the drug regulator's demand for a local clinical trial.

COVID-19 Vaccine

Globally, 119.48 million have received vaccinations.

Countries are facing headwinds in accelerating vaccinations due to supply disruptions and capacity shortages for delivery. Israel, despite the slowdown, has successfully inoculated almost 40 percent of its population.

Markets

European Union regulators may intervene after a surge in online share trading by retail investors since restrictions to tackle the COVID-19 pandemic were introduced, the bloc's securities watchdog said on Thursday.

- European stocks rose on Friday, tracking an upbeat Oil hit its highest level in a year above \$59 a barrel sentiment from Wall Street on hopes of a faster global economic recovery.
- Asia-Pacific equities gained on Friday, following on The dollar headed for its best weekly gain in three from record highs on Wall Street amid signs of improvement for the US labor market.
- **US stock futures** rose Friday, suggesting the S&P 500 is poised for its best week in three months, on investors' bets that a fresh coronavirus-relief spending package will bolster the economy.

- on Friday supported by hopes of a quicker economic revival and supply curbs by OPEC and its allies.
- months, lifted by growing confidence that the US economic recovery will outpace global peers.
- A sell-off in 30-year US Treasuries has pushed the US yield curve — which shows the difference between short- and long-term government bond yields — to its steepest level in more than five years.

Business

Australian farmers have warned that the country's trade dispute with China and supply chain disruptions linked to the coronavirus pandemic will cost the industry \$28 billion over the next decade.

- South Korea unveiled a 48.5 trillion won (\$43.2 billion) plan to build the world's largest wind power plant by 2030 as part of efforts to foster an environmentally-friendly recovery from the COVID-19 pandemic.
- Luckin Coffee has filed for bankruptcy protection in the US, less than a year after the China-based coffee chain said hundreds of millions of dollars of sales had been fabricated.
- CVC Capital Partners is in talks to buy a minority stake in the San Antonio Spurs at a roughly \$1.3 billion valuation, in a move that signals how private equity is poised to reshape the ownership structures of National Basketball Association franchises.

- Kuaishou Technology more than doubled in its Hong Kong stock market debut on Friday, becoming the fifth-largest listed company in the city, driven by massive demand from mom-and-pop investors for the Chinese online video service operator.
- **Gilead** generated almost \$2 billion in revenue from its COVID-19 drug in the fourth quarter, helping the US biotech's sales soar 26 per cent and beat expectations.

Africa

- **Zimbabwe** will receive 200,000 free doses of China's Sinopharm COVID-19 vaccine, President Mnangagwa announced.
- The trial of fourteen suspects in the 2014 beheading of French mountaineer Hervé Gourdel has been postponed until February 18, a court in Algeria ruled on Thursday, citing the main suspect's poor health.
- Ivermectin manufacturer Merck reported it found "no scientific basis" for use of the drug in treating COVID-19 patients, after it was approved by South African health authorities for cases "deemed urgent."
- Mozambique imposed a curfew on the Maputo area as its buckles under rising cases of coronavirus; this is the first curfew since the civil war ended in 1992 and will last from February 5 to March 7.





Asia

- A US warship sailed near the Chinese-controlled Paracel Islands in the disputed South China Sea on Friday in a freedom of navigation operation;
 China says it has irrefutable sovereignty and has accused Washington of deliberately stoking tension.
- The number of COVID-19 infections in Tokyo may have jumped by nine-fold since last summer, coronavirus antibody tests showed, as Japan tries to rein in the country's third and most lethal wave of the pandemic ahead of the Olympics in July. AstraZeneca filed for Japan's approval of COVID-19 vaccine, making it the second pharmaceutical firm to do so after Pfizer Inc.
- At least one in five of **India's** 1.4 billion people have been infected by the coronavirus, according to a recent study carried out by the Indian Council of Medical Research.
- **Myanmar** police arrested another key aide of ousted leader Aung San Suu Kyi and media said at least 30 people had been detained over pot-banging protests against a military coup as shows of anger gathered pace on Friday. Teachers became the latest group to join a civil disobedience campaign with some lecturers refusing to work or cooperate with authorities.
- A panel of South Korean advisers has urged caution over the use of AstraZeneca's COVID-19 vaccine for people older than 65, citing a lack of data.

Europe

- The **EU's** top diplomat told **Russian** authorities on Friday that their treatment of jailed opposition politician Alexei Navalny represented a low point in ties as Navalny appeared in court again over a slander case.
- **Turkey's** interior minister accused the US of being behind a 2016 failed coup prompting a curt and categorical denial, calling the remarks unfounded, irresponsible and inconsistent with Turkey's status as a NATO alley and strategic partner.
- Britain revoked the license of CGTN, the Chinese English-language sister channel of state broadcaster CCTV, after concluding that China's ruling Communist Party had ultimate editorial responsibility for the channel. In the past year the UK expelled three Chinese spies who were in the country on journalism visas, according to a report by The Telegraph.
- The European Commission is in talks to acquire doses of the US-based Novavax COVID-19 vaccine. UK COVID-19 daily cases have fallen 70 per cent to end-of-November levels, the drop attributed to the reimposition of the national lockdown. Britain will place travelers arriving from COVID-19 hot spots in quarantine in hotels from February 15. Italy surpassed 90,000 deaths and Germany, 60,000 deaths.
 Poland's hotels, cinemas and theatres will be able to reopen partly next week as the country becomes one of the first EU nations to ease the latest coronavirus-induced restrictions. Northern Ireland will give students a one-off cash payment of £500 in compensation for the disruption they have suffered during the pandemic.

Middle East

- French President Macron welcomed the renewed US willingness to engage with Iran, offering himself as an honest broker and that Saudi Arabia and Israel must ultimately be involved somehow in the process.
- Saudi Arabia welcomed US President Biden's commitment to help the Kingdom defend its people and territory. The Kingdom has repeatedly been the target of missiles and drones launched by Iran-backed Houthi militants in Yemen.
- The International Court of Justice rejected a case brought by **Qatar** accusing the **UAE** of discrimination during a blockade of Doha, which has since been lifted.
- Hundreds of Europe-bound migrants were intercepted in the Mediterranean Sea off Libya's coasts and taken into detention over the last 24 hours by the Libyan navy. The UN Security Council ordered the deployment of ceasefire monitors to war-torn Libya, with the approval of the warring parties.





Americas

- **Brazil** is in talks to buy an additional 20 million doses of the coronavirus vaccine developed by **China's** Sinovac Biotech, in a show of confidence in the efficacy of the vaccine. Brazil now has over 100 million doses of CoronaVac on order. Brazil's prosecutor-general has opened a preliminary investigation into its president and health minister for possible negligence in response to a COVID-19 outbreak in Manaus city.
- Panama's government is seeking 3 million doses of Russia's Sputnik V vaccine against COVID-19 for 1.5 million people, hoping to receive them by March.
- Paraguay signed a contract with the Russian Direct Investment Fund to purchase the Sputnik V vaccine.
- International Rescue Committee urged Mexico to follow the US lead and allow all migrants, regardless of their immigration status, to be vaccinated against COVID-19. Mexico has promised a universal, free vaccination program but has not specified whether migrants in the country, most of them Central American, will be eligible.
- Canadian officials are defending a decision to accept coronavirus vaccines from a program aimed primarily at helping low- and middle-income countries, saying that drawing doses from the COVAX facility was always part of its strategy.



Americas: US

- Nationally, 28.2 million Americans have received at least one dose of coronavirus vaccine. US coronavirus hospitalizations fell below 90,000 for the first time since late November, while cases rose by the most in five days. Indiana added an addition 1,500 deaths to its records after completing an audit, bring the state to 11,597 total coronavirus deaths.
- US officials in Texas are releasing an increasing number of Central American migrant families from custody as
 local authorities in Mexico have baulked at taking them back and border patrol facilities risk becoming overcrowded.
- The House voted to strip Marjorie Taylor Greene of her committee assignments over the controversial Republican lawmaker's previous endorsement of conspiracy theories. All of the Democrats voted in favor of the motion, as did 11 Republicans.
- New US jobless claims dropped to their lowest level since November. The Senate approved a budget bill that paves the way for passage of President Biden's \$1.9 trillion coronavirus relief package, with Vice President Harris casting the tiebreaking vote.
- President Biden, in his first major foreign policy speech, promised a new era of US foreign policy and said he had told President Vladimir Putin that the days of the US rolling over in the face of what he called Russia's aggressive actions were over. Biden also declared a halt to US support for a Saudi Arabia-led military campaign in Yemen, calling for an end to the war. Biden named Timothy Lenderking, a long-serving US diplomat in the Middle East, as a special envoy to Yemen.

Emerging & Existing Hotspots: A New Push to End Yemen's Civil War

In his first major foreign policy speech, President Biden announced that he would be ending US support for offensive operations in Yemen. As part of his remarks, Biden also called for an end to the war. These statements attempt to draw a clear line between the controversial Yemen policies of the last two Administrations and US policy going forward. They should not, however, be interpreted to mean that the US no longer plans to play a role in Yemen. The Biden and senior Administration officials have indicated that engagement with both Yemen and partners in the region will continue, but with shifted priorities. It is less clear whether the US has sufficient leverage to break the stalemate that is perpetuating Yemen's crisis.

In line with commitments made during the campaign, President Biden has outlined a new policy agenda that will redefine the US role in the conflict. The early stages of this policy shift focused on reviewing Trump Administration decisions. One priority for the Biden Administration was reviewing the Trump Administration's decision to designate the Houthis as a Foreign Terrorist Organization (FTO). Even prior to the decision, humanitarian and international organizations warned that the designation could push Yemen closer to famine. Secretary of State Blinken said he is "particularly focused" on the designation and has temporarily suspended some of the

sanctions in response to humanitarian concerns. The most headline grabbing shift was the decision to withdraw US support for the Saudiled coalition's offensive operations. As part of cutting support the Biden Administration also placed under review and then halted arms sales to Saudi Arabia associated with offensive operations. Under Biden's new strategy, the US is instead redoubling its push for a political solution by appointing a Yemen envoy. Biden emphasized during his remarks that the US would still help boost the defenses of Saudi Arabia to protect against cross border drone attacks from the Houthis.

Emerging & Existing Hotspots: A New Push to End Yemen's Civil War

Though often framed as a simple proxy war between Iran and Saudi Arabia, the conflict in Yemen is rooted in local disputes. What began as a Houthi power grab in the aftermath of Arab Spring protests has now devolved into a civil war, drawing in a range of international backers. With Iranian arms and training, the Houthis continue their attempts to push into southern and eastern Yemen, however their offensives have made little progress. The uneasy alliance between the Southern Transitional Council (STC) and internationally recognized government of President Abd-Rabbu Mansour Hadi has held out with the support of a Saudi Arabia-led coalition, but fighting has not been limited to the frontlines. Divisions between the Hadi government and STC have flared up into open conflict, often triggered by the STC's pursuit of independence. Al-Qaeda in the Arabian Peninsula has also been active in Yemen, filling vacuums left behind as the factions and their backers compete.

Even if mediators could reach a political solution to the conflict, Yemen would still face several crippling challenges. Fighting between the factions has devastated Yemen's already underdeveloped economy and healthcare system with dire consequences for the population. Yemen is dealing with outbreaks of both cholera and

COVID-19. The country has been on the brink of famine for years, but international humanitarian efforts have faced Houthi obstructionism and government corruption. A recent UN report accused the Hadi government of laundering hundreds of millions of dollars that was deposited in the Central Bank to buy food. This is likely to fuel questions about the internationally recognized government's legitimacy, which has already been strained by a long period in exile. The Houthis, meanwhile, are risking an environmental catastrophe by stalling the UN's efforts to prevent a dilapidated oil tanker moored off the coast of Yemen from leaking. While the Biden Administration is likely to place more of an emphasis on resolving the crises in Yemen, there are no quick fixes and Yemen is likely to remain on the US agenda for the foreseeable future.



Key Takeaways from OSHA's COVID-19 Guidance

At the direction of the Biden Administration, the Occupational Safety and Health Administration (OSHA) published new guidance on preventing the spread of COVID-19 in the workplace last week. The guidance covers many well-known elements of COVID-19 control: how the virus spreads, the importance of face coverings, the need to avoid close contact, and good hygiene practices.

Beyond the broad overview of virus mitigation measures, the guidance directs employers to implement COVID-19 prevention programs in the workplace, providing detailed descriptions for office best practices for everything from the best type of vacuum filter cleaners should use to precise quarantine guidelines for workers exposed to the coronavirus. Informational in content, the guidance is not a legally binding OSHA standard - but it does provide a view of what may be included in a coming Emergency Temporary Standard (ETS), which OSHA could implement as soon as mid-March.

Mask wearing, social distancing, and good hygiene have all become redundant concepts in COVID-19 control, but OSHA's guidance can help employers establish the details of how to ensure these broad practices are actually implemented. The guidance explains precisely in which instances workers should wash their hands, how ventilation systems should be improved, and methods for enforcing six feet of distance between workers (everything from tape marks on the floor to staggering remote work shifts).

Key Takeaways from OSHA's COVID-19 Guidance

- Beyond advice for how to tailor the physical workspace for COVID-safety, the guidance includes several broader recommendations that should be included in COVID-19 employer plans:
- Assign a workplace coordinator who will be responsible for COVID-19 issues on an employer's behalf.
- Focus on establishing systems of effective communication with employees. This includes ensuring workers can report COVID-19 exposure or symptoms without fear of reprisal, as well as educational initiatives such as signs detailing COVID-19 protocols.
- Set up an anonymous process for workers to voice concerns about COVID-19-related hazards.
- Provide guidance for workers on testing and screening, following state and local practices.
- Minimize the impact of quarantine and isolation for workers,

through telework, isolated work areas, or paid leave.


- Make COVID-19 vaccines available at no cost to all eligible employees and provide training on the benefits and safety of vaccinations.
- Do not distinguish between workers who are vaccinated or unvaccinated, as there is still too little information to determine what role vaccinated individuals may play in virus transmission.
- These guidelines will be updated to reflect developments in science, standards, and best practices. For example, the recommendation to treat vaccinated and unvaccinated workers the same, in terms of transmission risk, could change in the future as scientists build understanding of whether vaccines prevent transmission and policymakers weigh the need to incentivize vaccinations.

As of 2100 hours US EDT on February 4, 2021




Confirmed Cases (New)




