

WHAT WE'RE WATCHING

Tension remains high in Russia today as US and Ukrainian diplomats face deadlines to leave the country, while Russian forces continue to amass along the border with Ukraine. There are an estimated 120,000 troops in Rostov Oblast, the most since 2014 prior to the annexation of Crimea.

Yesterday saw thousands of protestors take to the streets during President Putin's aggressive and nationalistic state of the nation address. Putin said he "hoped" no foreign actor would cross Russia's "red lines," likely a reference to elevated conflicts on the Russian-Ukrainian border and possibly a pretext for military incursions into the Donbass.


Confirmed coronavirus infections topped 143.7 million with 3.0 million deaths.

 Europe experienced its hottest year on record last year, while the Arctic suffered a summer of extreme wildfires partly due to low snow cover as climate change impacts intensified, per the Copernicus Earth observation service.



Global

Yesterday's reported new coronavirus cases blew past the January 8, 2021 high, registering 893,072 new infections. India also reported a record high for new infections, 315,802, with 2,102 deaths.

COVID-19 Vaccine

The European Commission is planning to sue AstraZeneca after the company cut COVID-19 vaccine deliveries to the EU.

- New interim data shows that India's Covaxin
 COVID-19 vaccine is 78 percent effective.
- Pfizer has identified **counterfeit versions** of its vaccine in Mexico and Poland.
- Russia's sovereign wealth fund has signed a deal with Egyptian pharmaceutical group Minapharm to produce more than 40 million doses a year of Russia's Sputnik V vaccine.
- Syria's government has received its first delivery of COVID-19 vaccines through the global COVAX initiative, with almost 200,000 doses of the AstraZeneca vaccine.
- Norway is "lending" its entire stock of Oxford/AstraZeneca Covid-19 vaccines to Sweden and Iceland, after putting the vaccine on hold for a second month.

Markets & Business

The number of UK companies in significant financial distress has risen at the fastest rate in more than seven years and is expected to spike when the government ends Covid-19 support at the end in the summer.

- Wednesday, Wall Street rose in a broad rally after two days of decline.
- The **Nikkei 225** in Japan jumped more than 2 percent on Thursday, recovering partially from two days of losses earlier in the week.
- SmartRent.com Inc., which sells smart home-technology systems to apartment-building owners and developers, intends to go public through a merger with a special-purpose acquisition company that values the property-tech startup at \$2.2 billion

- Ford is planning to extend shutdowns at a number of US plants as the chip shortage continues to limit production.
 Daimler cut hours for 18,500 workers.
- **Tesla** came under further regulatory and media pressure in China after apologizing to a disgruntled customer who protested allegedly faulty brakes on Monday and promising to establish a customer satisfaction unit in the country.
- **Informa**, the world's largest exhibitions business, lost £1.1 billion before tax last year, as the pandemic forced it to cancel events and write down the value of its portfolio.

Africa

- France announced that it is ready to grant Sudan a \$1.5 billion bridge loan to clear its IMF arrears and allow it to seek debt relief.
- **Chadian** opposition parties decried the appointment of the late President Deby's son to be interim president as a "*coup d'état*."
- The leaders of Angola, Rwanda, Congo and the Central African Republic met on Wednesday to discuss the insurgency in CAR.
- The **Zimbabwean** parliament approved constitutional changes, including a provision allowing the president to appoint the vice president, previously an elected position. Opponents say the move entrenches President Mnangagwa's power.






Asia

- Diplomats said that the **EU and India** are in talks to work together on joint infrastructure projects around the world to compete with **China's** Belt and Road.
- The **Australian** government said Wednesday that it will cancel agreements between **China** and the state of Victoria cooperating on the Belt and Road Initiative.
- At least four people were killed and a dozen injured by a bomb explosion at a hotel hosting the **Chinese** ambassador in **Pakistan**.
- A spokesperson for Myanmar's leader said that Senior General Min Aung Hlaing, leader of the military junta governing the country, will attend an ASEAN summit on Saturday. Food insecurity is rising sharply in Myanmar in the wake of the military coup, the UN warned.
- Japanese Prime Minister Suga canceled a planned visit to India and the Philippines later in April due to the need to accress COVID-19 at home.
- India's economic outlook is weakening as the COVID-19 situation continues to worsen. India recorded the world's highest daily tally of 315,802 new COVID-19 infections on Thursday, with most New Delhi hospitals full and running out of oxygen.
- China has administered about 200 million coronavirus vaccine doses as part of an effort to inoculate 40 percent of its population by mid-June.

Europe

- Ireland's finance minister said the country will push for a global corporate tax agreement that "accommodates" current low tax jurisdictions.
- Next week, **Italian** Prime Minister Draghi will unveil a €221 billion recovery package to restructure Italy's economy.
- **Germany's** constitutional court removed a key obstacle to the development of the **EU** recovery fund.



- The European Commission is facing backlash after delaying its decision over green energy classifications for power sources like nuclear and natural gas. The EU came to an agreement on new emissions targets after months of negotiations. Climate activists shattered windows at HSBC's headquarters in London as part of a protest against the financing of what the group says is devastating climate change that threatens the planet.
- Europe surpassed 50 million total coronavirus infections. The Swiss government said that vaccine passports are likely to be a key part of reopening plans. France will impose new restrictions on travelers from India due to variants in the country. Turkey recorded its highest daily death toll of the pandemic.
- Russia arrested over 1,000 at pro-Navalny protests across the country on Wednesday. France's foreign minister told Russia that the EU would impose sanctions if jailed critic Alexei Navalny dies.

Middle East

- Iran has installed additional advanced centrifuges at its Natanz nuclear plant, per the IAEA. The US has reportedly laid out several potential areas of sanctions relief for Iran, including oil and finance, if a new nuclear deal is reached.
- COVID-19 infections in Iraq surpassed 1 million.
- Syria was stripped of its voting rights at the Organization for the Prohibition of Chemical Weapons for its history of chemical weapons use.
- Israel has expanded air strikes on suspected Iranian missile and weapons production centers in Syria to stop Iran's military encroachment. Israeli army Chief of Staff Aviv Kochavi said in December that there were more than 500 Israeli missile strikes in 2020 alone and operations would continue.





Americas

- **Canada** has become the first G7 country to scale back monetary policy measures aimed at mitigating the pandemic's impact, raising its growth forecast.
- A Canadian court agreed to delay US extradition hearings for Huawei CFO Meng Wanzhou for three months.
- Governor of the **Brazilian** Sao Paolo state Joao Doria will seek his party's nomination to run against Bolsonaro in next year's elections.





Americas: US

- Across the nation, 134.4 million people have received at least one dose of vaccine, representing 40.5 percent of the total population. President Biden called for US businesses to offer paid time off for employees to get vaccinated. President Biden cast getting vaccinated as a patriotic duty.
- The Justice Department opened a probe into whether there is a pattern of **unlawful police conduct** in the Minneapolis police department.
- The White House will host the first day of its **Leaders Climate Summit**, a 40-country summit to discuss climate cooperation in which Chinese President Xi will reportedly speak. On the eve of the summit, governors of 12 states asked Biden to back efforts to phase out gas cars, and the US announced it will join a global effort to reach zero emissions in shipping by 2050.
- The US officially removed **Turkey** from the F-35 project.

The United States' relationship with Turkey is among the most complicated and contentious relationships that President Biden must navigate in the coming years. The past several years have been characterized by fairly close leader-level relations under President Trump, and the US still relies on Turkey for crucial cooperation against ISIL and the Assad government in Syria (outside of the northeast, where the US cooperates with the YPG), as well as the potential need for future partnership on Ukraine, Afghanistan, and Libya. Nonetheless, stark divides on the Kurds in Syria, the Turkish purchase of the Russian S-400 platform, and accusation of democratic backsliding have driven deep wedges in Ankara-Washington relations.

Recent analysis and reporting in Washington, DC details the tensions and trade-offs inherent in the bilateral relationship. A memo recently published by the Washington Institute for Near East Policy, "titled Defining a Realistic Policy Toward Erdogan's Turkey: Advice for the Biden Administration," addresses the core problems in the relations, identifies main areas of cooperation between them and examines the impact of Turkish domestic politics on the relations. Per the report, the two core problems in the bilateral relations are Turkey's purchase of the S-400 surface-to-air missile system from Russia, and US cooperation with the Kurds in Syria. Each side is blaming the other for not fulfilling their NATO obligations, and it will be extremely difficult to resolve these differences.

The close relationship between Russia and Turkey is a significant sticking point for the US. While Russia and Turkey are not allies, the close Putin-Erdogan bond (forged in the immediate aftermath of the 2016 failed coup attempt) grounds the relationship. Russia gave Turkey a "green light" to enter northeast Syria to fight the Kurds, and in return Erdogan agreed to purchase the S-400. The memo assesses that the Turkish president knows he has to do something to repair his relations with Washington - Turkey's exclusion from the F-35 program dealt a serious blow to a bilateral relationship primarily grounded in defense ties, and if Turkey continues to be excluded from the project, defense ties as they are currently known

will end. Turkey will not be admitted back into the project without a major concession on the S-400, however, a step Erdogan likely estimates he cannot afford to take. US support of the Syrian Democratic Forces (SDF), a Kurdish-led militia with which the US partners in northeast Syria and which Turkey does not differentiate from the YPG, which it considers a terrorist group, is another central issue. On the other hand, Turkey has launched several full-scale military operations in the northeast, and is the largest anti-Assad force in Syria. As the US withdraws troops from the Middle East, it seems highly unlikely that its cooperation with the YPG will end. Short of a "grand bargain" involving a quid pro quo between the S-400 and YPG issues, these problems seem intractable.

Nonetheless, there remain important areas of current or potential cooperation between the two countries, including on Afghanistan, Ukraine, Syria (outside of the northeast), Libya and China. Turkey is accepted by all parties in Afghanistan and could play a constructive role in mediation. In Ukraine, Turkey is aligned with the US in refusing to accept Russian annexation of Crimea. Turkey has kept Russia at bay in Libya, and there is a potential for defense cooperation with the US. On China, Turkey has close ties with the

Uyghurs and could find a common agenda with the Biden Administration on this issue.

Domestically, Erdogan's numbers in public opinion polls are slipping. Support for the president is at its lowest point since 2002, with only a third of the electorate on his side. This slip has several possible causes - the Turkish economy has been in recession since 2018, there is a fatigue after 20 years of Erdogan rule and Erdogan is no longer seen as a problem-solver as he once was. There is decreased support for the president among young Turks, where there is a clear desire for change. Erdogan may be humbled in the 2023 elections and may, according to some analysts, attempt to call the electoral process rigged., it is hard to envision Biden embracing Erdogan in such a context.

In the words of Turkey expert Asli Aydintasbas of the European Council on Foreign Relations, US-Turkey relations were never a "perfect marriage," but they had been a strong one. A Turkish analyst argues that the WINEP memo does not take into account Erdogan's pragmatism, and one cannot rule out he may easily change policies and behavior if he believes it will serve his interests.

The backsliding of the western-led liberal order and Turkish democracy can be reversed, and if Biden does indeed succeed in "resuscitating" American leadership of the liberal order, Turkey will not be able to remain impartial to international and domestic pressure to restore some democratic norms. The state of the Turkish economy will, of course, play a critical role in this calculus. Aydintasbas acknowledged the risk of an Erdogan attempt to call into question the results of the 2023 election, but argued that that if there is a stronger showing of the opposition and a more decisive electoral map, this will be more difficult.

Max Hoffman of the Center for American Progress painted a pessimistic picture of bilateral ties. No one in Washington takes Erdogan's "charm offensive" vis-a-vis the US and Europe seriously; however, the US has treaty obligations, and policymakers are not eager to adopt a punitive approach toward Ankara. While Turkey is not a top issue on Biden's priority list, keeping a healthy distance from Erdogan's Turkey is nonetheless a policy choice in and of itself. The fact that Biden has not called Erdogan yet is a reflection of this approach, as well as Biden's policy of seeking institutionalized,

rather than personalistic, relations with his counterparts. Hoffman predicted that if the administration succeeds in maintaining a tenuous status quo, it will consider it a win. Hoffman argues that between 2018 and 2021, Erdogan has been trying to assert itself and revise the regional order (such as in Syria, Libya, Eastern Mediterranean). If all the US and Europe want is to get to 2023 safely, Erdogan may get the impression they have acquiesced with his policy.

Jenny White, a professor of Turkish studies in Sweden, agrees with Hoffman that Erdogan is very pragmatic, but argues that it is difficult to envision him restoring some democratic legitimacy as a result of internal or external pressure, as it may risk his own position. White takes a cynical line on Turkish foreign policy, arguing that his foreign policy is directed at his home audience, as foreign policy is understood by Turks in personal terms - it is deeply embedded in the national psyche. Further, she argues, it is a vehicle for Erdogan to promote his interests and enrich himself and his close associates and therefore not "rational" - as such, there is very little that the US can do.

Despite numerous potential areas for cooperation, analysts are largely in agreement there will be no improvement in American-Turkish dynamics in the foreseeable future. The absence of a phone call from Biden to Erdogan thus far reflects the new administration's transactional, hands-off approach to Turkey. While Erdogan may eventually be capable of a foreign policy pivot, that does not seem to be the case at the moment. The challenge from the American and European perspective will be to stand together vis-a-vis Turkey, while at the same time striving to keep Turkey in NATO. Relations

between Washington and Ankara might be tested again very soon there are reports of a possible White House declaration on April 24 recognizing the Armenian Genocide. If the Biden Administration decides to issue such a declaration, it may spark a new crisis in the relationship. Much will depend on the wording of the declaration and also on how Erdogan responds.




Coronavirus Condition Updates

As of 2100 hours US EDT on April 21, 2021




Confirmed Cases (New)




