On November 6, President Obama announced his decision to deny TransCanada's application for approval to build the Keystone XL Pipeline. The working text (all 5,500+ pages) of the 12-country Trans-Pacific Partnership Agreement (TPP) was <u>released</u> to the public on November 5. This text is still undergoing an intense legal scrub and must be translated into its other official languages prior to signature. With the text now public, the Administration has an opportunity to demonstrate to a skeptical Congress and to the American public how the TPP has achieved its ambition of a "21st Century Agreement" that promises benefits for American farmers, businesses, and workers. Once implemented, the agreement among Australia, Brunei Darussalam, Canada, Chile, Japan, Malaysia, Mexico, New Zealand, Peru, Singapore, United States, and Vietnam will create an integrated regional economy accounting for 40 percent of global GDP.
