JUDGMENTS

New South Wales (NSW)

13 April 2015 - Sarah White v The Local Health Authority & Anor - [2015] NSWC 417

The New South Wales Supreme Court has ordered the release of a person unlawfully detained in a mental health facility.

The applicant, who is subject to a guardianship order, was voluntarily admitted to the facility in November 2013. In January 2015, the Mental Health Review Tribunal reviewed the applicant's admission, as required by the *Mental Health Act 2007* (NSW). The Tribunal found that the applicant did not have a current mental illness requiring hospital admission, and ordered that the applicant be discharged from the facility on 10 February 2015.

The facility delayed the applicant's discharge in order to make arrangements for the applicant's future accommodation in consultation with the Public Defender, the applicant's guardian. Under the terms of the applicant's guardianship order, the Public Defender had the authority to decide the applicant's accommodation.

The applicant contended that when she was not released on 10 February 2015 as had been ordered by the Tribunal, she was no longer being held in the facility as a voluntary patient. After the applicant's repeated requests to leave the facility were disregarded, she applied to the court for a habeas corpus order seeking her release.

The Court found that there was no statutory authorisation to keep the applicant in the facility. While the Court noted that it had "grave misgivings" about the wisdom of releasing the applicant from the facility without a plan for her immediate future, it held that she was entitled to be released.

15 April 2015 - *Dharmalingham v Western New South Wales Local Health District* - [2015] NSWCATAD

The New South Wales Civil and Administrative Tribunal has found that the Western New South Wales Local Health District discriminated against an employee on the basis of his race.

The applicant was employed as the Director of Pharmacy at the Bathurst Base Hospital. He alleged that his employer, the respondent, had discriminated against him on the basis of his race, disability and carer's responsibilities. The applicant also alleged that he was victimised for bringing proceedings in relation to those claims.

While the Tribunal held that a number of the applicant's claims could not be substantiated, it found that the applicant had been discriminated against in relation to a complaint made about the applicant speaking in his native language at work.

The Tribunal found that the applicant had become aware that his colleague filed a complaint stating that it was inappropriate for the applicant to speak his native language on the telephone while at work, and that this made her uncomfortable. The Tribunal found that this constituted discrimination, as the applicant was treated less favourably due to his race.

In its decision, the Tribunal noted that the respondent had failed to take steps to implement training regarding 'issues relating to persons from a non-English speaking background.'

The Tribunal also held that the respondent had victimised the applicant when it placed him on special leave while investigating allegations made against him.

The Tribunal held the respondent vicariously liable for the actions of its employees, and awarded the applicant \$10,000 in damages.

'I would like to acknowledge the patient for following the appropriate protocols in rapidly informing ACT Health of her symptoms late last week.' 'This incident again shows that ACT Health is well prepared for handling conditions like Ebola.' 'ACT Health would also like to thank the media for their cooperation and measured reporting of the handling of this incident,' Dr Kelly said.

10 April 2015 - Canberra patient's first test results negative - ACT Health ACT Acting Chief Health Officer Dr Andrew Pengilley this morning said the first Ebola test conducted on a female patient at Canberra Hospital has returned a negative result. 'This is the first of two tests that are undertaken as part of the Ebola protocols followed by ACT Health. The next will be conducted tomorrow morning with the results expected on Monday (13 April). 'In addition to the good news that the first test is negative, I can also advise that overnight the patient's condition has improved.'

10 April 2015 - Canberra Patient Being Tested for Ebola 10.04.15 - ACT Health Acting Chief Health Officer, Dr Andrew Pengilley today confirmed that as a precautionary measure a person who recently returned from West Africa has been admitted into the dedicated Canberra Hospital isolation ward. The precautionary admission was a result of ACT Health's monitoring program following symptoms that developed this afternoon. This will allow the person to be medically assessed, including undergoing testing for the Ebola Virus. The person, who worked as a medical professional in Liberia, has been undergoing monitoring since their return from overseas as required by ACT Health procedures. Due to the low number of cases in Liberia recently, the person did not treat any cases of Ebola.

1 April 2015 - National Seclusion and Restraint Reduction Forum - The 10th National Seclusion and Restraint Reduction Forum (28 & 29 May 2015) aims to reinvigorate the national conversation about reducing seclusion and restraint. The theme for the forum is 'From here to there: Shaping the path to harm free care'. In recognition of over a decade of commitment to reducing the use of restrictive practices, the theme asks presenters and participants to reflect on real world lessons and the innovation and ideas that have arisen from research and practice.

15 April 2015 - Statement on recycled water connection incident - Victorian Government agencies are taking action in response to an incident at a school in Melbourne's south east in which recycled water was connected to a drinking water fountain. The issue was detected by a maintenance worker at St. Peters College Cranbourne East campus and South East Water was alerted on 1 April. The school community, including parents and teachers, have been notified and provided with the relevant health and other information. After the college notified South East Water, which confirmed that a recycled water supply line had been connected to the drinking fountain, supply to the drinking fountain was immediately cut off. Following the detection of the issue, the Department of Health & Human Services (DH&HS) immediately began an assessment of the potential for any impact on the health of the school community. Preliminary assessments indicate that the risk of illness from drinking this Class A recycled water is low – it may have led to a slightly increased risk of gastroenteritis.

14 April 2015 - **Another Step Toward Equality For People Living With HIV** - The Andrews Labor Government will improve equality before the law for people living with HIV by repealing an outdated, discriminatory law – the only offence of its kind in Australia. Delivering on another election commitment, the Government will today introduce legislation to repeal section 19A of the *Crimes Act 1958* – which contains a specific offence of intentionally infecting another person with a "very serious disease", defined exclusively to mean HIV. This is the only HIV-specific criminal offence in force in any jurisdiction in Australia. It singles out HIV and unfairly applies a harsher penalty for its transmission. The maximum penalty for the offence is

25 years imprisonment, even higher than the 20-year maximum penalty for manslaughter. The law has never been used in the circumstances for which it was originally enacted – the deliberate transmission of HIV by a blood filled syringe.
